# AMENDMENT NO. 1 TO North/East Maintenance District AGREEMENT BETWEEN SMITH & ENRIGHT LANDSCAPING, INC., AND CITY OF SALINAS

This Amendment No. 1 to the **North/East Maintenance District** Agreement is entered into this 25th day of June 2024, by and between the City of Salinas (the "City") and Smith & Enright Landscaping, Inc., (the "Contractor"). City and Contractor may be individually referred to herein as a "Party" and collectively the City and Contractor may be referred to as the "Parties."

#### RECITALS

WHEREAS, the City and Contractor first entered into an agreement for North/East Maintenance District effective June 22, 2021, pursuant to which Contractor agreed to act as and provide certain services to the City for compensation (the "Agreement"); and

WHEREAS, pursuant to Resolution 22149 (N.C.S.) the City Council awarded an agreement to Contractor for a three (3) year term, with the option for an additional two (2) year term with an inflation rate increase per the ENR Cost Index; and

WHEREAS, on February 15, 2024, Contractor submitted a written request to exercise the option for an additional two (2) year term with the request of the ENR Cost Index of 5% or less. The new cost for North/East Maintenance District will increase \$1,183.41 monthly from \$26,298.00 to \$27,481.41 per month.

NOW, THEREFORE, in mutual consideration of the terms and conditions set forth below, the Parties agree as follows:

#### **TERMS**

- 1. The term of the Agreement is hereby extended for a two-year period commencing on July 1, 2024, and ending on June 30, 2026.
- 2. The total amount of compensation to be paid by the City to the Contractor under the Agreement is hereby increased by \$ 1,183.41 per month to a monthly total of \$27,481.41, for a total amount of annual compensation not to exceed \$329,776.92.
- 3. All other covenants, terms, and conditions set forth in the Agreement and not amended by this Amendment No. 1 shall remain in full force and effect as if fully set forth herein.

IN WITNESS WHEREOF, the undersigned, as authorized representatives of the City and Contractor have entered into this Agreement as of the date first written above.



#### NOTICE TO BIDDERS

Notice is hereby given that the City of Salinas, County of Monterey, State of California (hereinafter referred to as "City"), hereby invites sealed Bid Proposals for the following work to be completed according to Plans and Specifications on file, to wit:

#### LANDSCAPE SERVICES FOR NORTH/EAST MAINTENANCE DISTRICT

A scanned copy of the Bid Proposal Package ("Bids") for the above-mentioned work shall be submitted electronically via the PlanetBids website until 2:00 p.m. Pacific Standard Time on May 25<sup>th</sup> 2021, at which time or thereafter said bids will be electronically opened and available online. A link to the meeting will be made available through PlanetBids. It is the Bidder's responsibility to ensure that said Bid shall be fully uploaded / transmitted via the PlanetBids website, prior to the aforementioned designated date and time. The City will not be accepting paper bids.

Disability-related modification or accommodation, including auxiliary aids or services, may be requested by any person with a disability who requires a modification or accommodation in order to participate in any meetings for this project. Requests should be referred to the City Clerk's Office at City Hall, 831-758-7381, as soon as possible but by no later than 5 p.m. of the last business day prior to the scheduled meeting. Hearing impaired or TTY/TDD text telephone users may contact the City by dialing 711 for the California Relay Service ("CRS") or by telephoning any other service providers' CRS telephone number.

No Bid shall be accepted from a Contractor who has not been licensed in accordance with the Provisions of Chapter 9 of Division 3 of the Business and Professions Code. Also, he/she is required to comply with all the requirements of the City of Salinas local hiring preference Ordinance 2330, Salinas City Code Chapter 12, Article IV, attached hereto, STATEMENT OF GOOD FAITH EFFORT FOR LOCAL HIRE and incorporated herein by reference, with respect to person(s) hired directly by the Contractor and to all persons hired by the Contractor's Subcontractor(s). Contractor shall possess a Type "{ C-27, Type C-61/D-49}" license or other license qualifying the Bidder to Bid as a prime Contractor prior to SUBMITTAL of Bid and the license must be valid prior to award and throughout the Contract as approved by Council.

In determining the lowest bid for a public works contract that exceed \$5,000.00, a qualified local business shall receive a five-percent (5%) preference, per the City's Local Purchasing Preference Ordinance (Sec. 12-28.050 and Sec. 12-28.060).

In order to be recognized as a local business, Contractors must submit a Declaration of Local Business Form to the City's Finance Department.

The City of Salinas reserves the right to reject any or all Bids and to waive any informality in Bids received.

By submitting a Bid, it is assumed that the Contractor has evaluated the site and the Bid submitted reflects that the Contractor is satisfied as to the existing conditions, said conditions being reflected in the Bid.

Each Bid shall be in accordance with the Specifications adopted therefore, submitted on the Proposal form furnished and accompanied by a certified or cashier's check or Bid Bond made payable to the City of Salinas, for an amount equal to at least *ten percent (10%)* of that amount of the Bid, such guaranty to be forfeited should the Bidder to whom the Contract is awarded fail to enter into the Contract within <u>15 calendar days</u> after notification of the award of Contract to the Bidder. The undersigned agrees that, in case of his/her default in executing the Contract and the necessary bonds after award and due notice thereof, the said check or bond and the money payable thereon shall become and remain the property of the City of Salinas as liquidated damages. The Contractor shall perform the work for the maintenance of the areas described for a period of three years (36) months from date of contract award.

For any moneys earned by the Contractor and withheld by the City of Salinas to ensure the performance of the Contract, the Contractor may, at his/her request and expense, substitute securities equivalent to the amount withheld in the form and manner and subject to the conditions provided in Section 22300 of the Public Contracts Code of the State of California.

A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5 . It is not a violation of this section for an unregistered contractor to submit a Bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

All Contractors (prime and subs) must possess and maintain such registration with the Department of Industrial Relations ("DIR") in order to be awarded and to perform work on public works projects. A bid shall not be accepted nor any contract or subcontract entered into without proof of the contractor or subcontractor's current registration to perform public work pursuant to Labor Code Section 1771.1.

This project is subject to compliance monitoring and enforcement by the DIR.

Additionally, all contractors and subcontractors must furnish certified payroll records directly to the Labor Commissioner (aka Division of Labor Standards Enforcement) on a weekly basis and in the format prescribed by the DIR, which may include electronic submission.

Bidders will be responsible for printing or obtaining on their own accord, hard copies of the Bid Proposal Package, Plans, Specifications, Prospective Bidders List and any addenda and notifications for their use in submitting a Bid.

Bidders are required to register as a Prospective Bidder for this project on the PlanetBids Vendor Portal website when submitting a Bid and shall maintain their status as "Bidder" throughout the Bid process; Bidders that fail to do so shall be disqualified. Failure to comply with these requirements may result in the forfeiture of the Bidder's rank in the Bid process.

In lieu of conflicting portions of "Section 2-1.05 Proposal Forms" of the Standard Specifications, the following shall apply:

Only Bids composed of the above listed items shall be considered for Award. Any and all Addenda to the Plans and Specifications shall be issued electronically on-line through the PlanetBids Vendor Portal website and <u>ONLY</u> to Bidders who are registered Prospective Bidders for this project on-line at the PlanetBids Vendor Portal website as having received a set of Plans and Specifications. The City shall not be responsible for issuance of said Addenda to non-registered Plan holders.


The successful Bidder and all Subcontractors must have a valid City of Salinas business license before the commencement of work.

All wage scales shall be in accordance with applicable determinations made by the Director of the DIR of the State of California, as provided by Article 2, Chapter 1, Division 2, Part 7 of the Labor Code of the State of California, commencing with Section 1771. In accordance with Section 1773.2 of the said Labor Code, copies of the aforesaid determinations of the Director of the DIR are available on the website address <a href="http://www.dir.ca.gov/OPRL/DPreWageDetermination.htm">http://www.dir.ca.gov/OPRL/DPreWageDetermination.htm</a>. It shall be mandatory for the Contractor to whom the Contract is awarded to pay not less than the applicable prevailing wage rate to all workers employed for the execution of the Contract and employ apprentices pursuant to Section 1777.5 of the California Labor Code.


The project shall involve the furnishing of all labor, material, equipment, and incidentals to perform the Landscape Maintenance in North East District in accordance with the Plans and these Special Provisions. The maintenance districts are as shown on the location map and described as follows:

#### **SECTION 1-1 SITE DESCRIPTION**

#### NORTH-EAST MAINTENANCE DISTRICT

- 1. **Constitution Boulevard** median island and appurtenant strip of land approximately 30 feet in width from face of east and west curb lines including planter walls from East Laurel Drive northerly approximately 10,100 feet to Boronda Road. (Approximately 13.63 acres)
- 2. **Independence Boulevard** median island and appurtenant strip of land approximately 30 feet in width from face of east and west curb lines to Constitution Boulevard northerly approximately 5,700 feet to Boronda Road. (Approximately 7.70 acres)
- 3. **Gabilan Creek** right of way approximately 100 feet in width more or less from a line approximately 3,800 feet northerly of East Laurel Drive, thence 9,200 feet more or less northerly to Boronda Road. (Approximately 20.7 Acres)
- 4. **Nantucket Boulevard** including appurtenant strip of land approximately 30 feet in width from face of north and south curb lines to and including adjacent planter walls from Independence Boulevard easterly approximately 5,000 feet to Constitution Boulevard. (Approximately 6.75 acres)
- 5. **Boronda Road** median island and appurtenant strip of land approximately 30 feet in width from face of north and south curb lines including planter walls from Natividad Road easterly approximately 14,500 feet to Williams Road. (Approximately 19.58 acres)
- 6. **Freedom Parkway** median island and appurtenant strip of land approximately 30 feet in width from face of north and south curb line including planter walls from Constitution Boulevard easterly approximately 6,800 feet to Williams Road and 6 walkways: to Madrone Drive, Palmera Avenue, Chamise Drive, La Cuesta Court, Cachuma Court, and Eagle Drive. (Approximately 9.18 acres)
- 7. **Nogal Drive** from a line 800 feet south of Freedom Parkway north approximately 1,400 linear feet including appurtenant strip of land approximately 30 feet in width along the east and west curb line to street terminus. (Approximately 1.89 acres)
- 8. **Rider Avenue** including appurtenant strip of land approximately 30 feet in width along the east and west curb line from a location approximately 1,200 linear feet south of Freedom Parkway northerly approximately 3,700 feet to Boronda Road including appurtenant planter walls. (Approximately 5.0 acres)
- 9. **North Sanborn Road** including median island and appurtenant strip of land approximately 30 feet in width from east and west curb lines including planter walls from Del Monte Avenue northerly approximately 4,900 feet to Boronda Road including 3 walkways; to Eagle Drive, Sage Court, and Rockrose Street. (Approximately 6.62 acres
- 10. **Towt Street** from Freedom Parkway westerly approximately 900 linear feet to Mae Avenue including appurtenant strip of land approximately 30 feet in width from curb line of east and west side of roadway including appurtenant planter walls. (Approximately 1.22 acres)
- 11. **Williams Road** from a line approximately 1,300 feet south of Freedom Parkway northerly approximately 3,500 linear feet to Boronda Road including median islands, 30-foot side strip of land along west curb line including appurtenant planter wall, and 4

- walkways: to Cougar Drive, Gaviota Drive, Raven Court, and between Mustang Court and Raven Court. (Approximately 2.36 acres)
- 12. **Buckhorn Drive** from Tamarak Way easterly approximately 2,000 feet to Falcon Drive appurtenant strip of land approximately 30 feet in width from curb line along south side of roadway including appurtenant planter wall. (Approximately 1.35 acres)



- 3. **Workers' Compensation**: as required by the State of California, with Statutory Limits, and Employers' Liability insurance with a limit of no less than \$1,000,000 per accident for bodily injury or disease.
- 4. Contractors' Pollution Legal Liability and/or Asbestos Legal Liability and/or Errors and Omissions (if project involves environmental hazards): with limits no less than \$1,000,000 per occurrence or claim, and \$2,000,000 policy aggregate, on an annual basis.

Property Damage - Borrowed Equipment

Unintentional Failure to Disclose Hazards

I. The Commercial General Liability Coverage Part is amended as follows:

#### A. SECTION I - COVERAGES

1. Coverage A Bodily Injury and Property Damage Liability

#### a. Exclusions

- (1) Exclusion g. Aircraft, Auto or Watercraft, is deleted in its entirety and replaced by the following:
  - g. Aircraft, Auto or Watercraft

"Bodily injury" or "property damage" arising out of the ownership, maintenance, use or entrustment to others of any aircraft, "auto" or watercraft owned or operated by or rented or loaned to any insured. Use includes operation and "loading or unloading."

This exclusion applies even if the claims against any insured allege negligence or other wrongdoing in the supervision, hiring, employment, training or monitoring of others by that Insured, if the "occurrence" which caused the "bodily injury" or "property damage" involved the ownership, maintenance, use or entrustment to others of any aircraft, "auto" or watercraft that is owned or operated by or rented or loaned to any insured.

This exclusion does not apply to:

- (1) an aircraft, with a paid crew, that is hired, chartered or loaned but is not owned by any insured:
- (2) a watercraft while ashore or at premises you own or rent;
- (3) a watercraft you do not own and that is:
  - (a) less than 51 feet long; and
  - (b) not being used to carry persons or property for a charge;
- (4) parking an "auto" on, or on the ways next to, premises you own or rent, provided the "auto" is not owned by or rented or loaned to you or the Insured;
- (5) liability assumed under any "insured contract" for the ownership, maintenance or use of aircraft or watercraft; or
- (6) "bodily injury" or "property damage" arising out of:
  - (a) the operation of machinery or equipment that is attached to, or part of, a land vehicle that would qualify under the definition of "mobile"

equipment" if it were not subject to a compulsory or financial responsibility law or other motor vehicle insurance law in the state where it is licensed or principally garaged; or

- (b) the operation of any of the machinery or equipment listed in paragraph f.(2) or f.(3) of the definition of "mobile equipment."
- (2) Exclusion j. Damage to Property is deleted in its entirety and is replaced with the following:

#### j. Damage to Property

"Property damage" to:

- (1) property you own, rent, or occupy, including any costs or expenses incurred by you, or any other person, organization entity, for repair, replacement, enhancement, restoration or maintenance of such property for any reason, including prevention of injury to a person or damage to another's property;
- (2) premises you sell, give away or abandon, if the

"property damage" arises out of any part of those premises;

- (3) property loaned to you;
- (4) personal property in the care, custody or control of the Insured;
- (5) that particular part of real property on which you or any contractors or subcontractors working directly or indirectly on your behalf are performing operations, if the "property damage" arises out of those operations;
- (6) that particular part of any property that must be restored, repaired, or replaced because "your work" was incorrectly performed on it.

Paragraph (2) of this exclusion does not apply if the premises are "your work" and were not occupied, rented or held for rental by you.

Paragraphs (3), (4), (5) and (6) of this exclusion do not apply to liability assumed under a sidetrack agreement.

Paragraphs (3) and (4) of this exclusion do not apply to the use of elevators.

Paragraph (4) of this exclusion does not apply to "property damage" to borrowed equipment while not being used to perform operations at a job site.

Paragraph (6) of this exclusion does not apply to "property damage" included in the "products -completed operations hazard."

(3) The last paragraph in 2. Exclusions is deleted in its entirety and replaced by the following:

Exclusions c. through n. do not apply to damage by fire, lightning or "explosion" to premises while rented to you or temporarily occupied by you with permission of the owner. A separate Limit of Insurance applies to this coverage as described in Limit of Insurance (Section III).

# 2. Coverage B Personal Injury and Advertising Injury Liability

#### a. 2. Exclusions

Exclusion **e.** is deleted in its entirety.

#### 3. Coverage C Medical Payments

Paragraph 1.a. of the Insuring Agreement is deleted in its entirety and replaced by the following:

- a. We will pay medical expenses as described below for "bodily injury" caused by an accident:
  - (1) on premises you own or rent;
  - (2) on ways next to premises you own or rent; or
  - (3) because of your operations;

provided that:

(1) the accident takes place in the "coverage territory" and during the policy period;

- (2) the expenses are incurred and reported to us within three years of the date of the accident; and
- (3) the injured person submits to examination, at our expense, by physicians of our choice as often as we reasonably require.

# 4. Supplementary Payments - Coverages A and B

Item **1.b.** is deleted in its entirety and replaced by the following:

b. Up to \$1,000 for cost of bail bonds required because of accidents or traffic law violations arising out of the use of any vehicle to which the Bodily Injury Liability Coverage applies. We do not have to furnish these bonds.

#### B. SECTION II - WHO IS AN INSURED

- Item 2.a.(1)(d) is deleted in its entirety and replaced with the following:
  - (d) Arising out of his or her providing or failing to provide professional health care services. However, this exclusion does not apply to nurses, emergency medical technicians or paramedics who are employed by you to provide medical or paramedical services.

#### 2. Items 2.e. and 2.f. are added:

e. Any subsidiary and subsidiary thereof, of yours which is a legally incorporated entity of which you own a financial interest of more than 50% of voting stock on the effective date of this Coverage Part. The insurance afforded herein for any subsidiary not named in this Coverage Part as a named insured does not apply to injury or damage with respect to which an insured under this Coverage Part is also an insured under another policy or would be an insured under such

policy but for its termination or the exhaustion of its Limits of Insurance.

- f. Any person or organization for whom you are performing operations when you and such person or organization have agreed in writing in a contract or agreement that such person or organization be added as an additional insured on your policy. Such person or organization is an additional insured only with respect to liability arising out of your ongoing operations performed for that Insured but
  - (1) coverage is no broader than coverage provided to you under this policy, and
  - (2) only to the extent of the applicable Limit of Insurance of this policy.

A person's or organization's status as an insured under this endorsement ends when your operations for that Insured are completed.

The insurance provided the Additional Insured(s) is limited to liability arising out of acts or omissions of the Additional Insured(s) in connection with their general supervision of "your work."

This insurance does not apply to "bodily injury," "property damage," or "personal and advertising injury" arising out of an architect's, engineer's, or surveyors' rendering or failure to render any professional architectural, engineering or surveying services, including:

- a. the preparing, approving, or failing to prepare or approve maps, shop drawings, opinions report, surveys, field orders, change orders or drawing and specifications; and
- **b.** supervisory, inspection, architectural or engineering activities.

- Paragraph 3. is deleted in it's entirety and replaced by the following:
  - 3. Any organization you newly acquire or form, other than a partnership, joint venture or limited liability company, and over which you maintain ownership or majority interest, will qualify as a named insured if there is no other similar insurance available to that organization. However:
    - a. coverage under this provision is afforded only until the 180th day after you acquire or form the organization or the end of the policy period, whichever is earlier;
    - b. Coverage A does not apply to "bodily injury" or "property damage" that occurred before you acquired or formed the organization;
    - c. Coverage B does not apply to "personal and advertising injury" arising out of an offense committed before you acquired or formed the organization.

No person or organization is an insured with respect to the conduct of any current or past partnership, joint venture or limited liability company that is not shown as a named insured in the Declarations.

#### C. SECTION III - LIMITS OF INSURANCE

- 1. Item 2. is deleted in its entirety and replaced by the following:
  - 2. The General Aggregate Limit is the most we pay for the sum of:
    - a. medical expenses under Coverage C;
    - b. damages under Coverage A, except damages because of "bodily injury" or "property

damages" included in the "products-completed operations hazard"; and

c. damages under Coverage B

at any one

- a. project away from premises owned by or rented to you;
- b. premises owned by or rented to you, involving the same or connecting lots or premises whose connection is interrupted only by a street, roadway, waterway or right-of-way of a railroad.
- 2. Item 6. is deleted in its entirety and replaced by the following:
  - 6. Subject to 5. above, the higher of \$300,000 or the Damage to Premises Rented to You Limit is the most we will pay under Coverage A for damages because of "property damage" to premises while rented to you, or in the case of damage by fire, lightning or "explosion," or temporarily occupied by you with permission of the owner.
- 3. Item 7. is deleted in its entirety and replaced by the following:
  - 7. Subject to 5. above, the most we will pay under Coverage C for all medical expenses because of "bodily injury" sustained by any one person is the higher of \$10,000 or the Medical Expense Limit shown in the Declarations.
- D. SECTION IV COMMERCIAL GENERAL LIABILITY CONDITIONS
  - Item 2. Duties in the Event of Occurrence, Offense, Claim or Suit - is deleted in its entirety and replaced by the following:
    - 2. Duties in the Event of Occurrence, Offense, Claim or Suit.

- a. You must see to it that we are notified as soon as practicable of an "occurrence" or an offense which may result in a claim. To the extent possible, notice should include:
  - (1) how, when and where the "occurrence" or offense took place;
  - (2) the names and addresses of any injured persons and witnesses; and
  - (3) the nature and location of any injury or damage arising out of the "occurrence" or offense.
- b. If a claim is made or "suit" brought against any insured, you must:
  - (1) immediately record the specifics of the claim or "suit" and the date received; and
  - (2) notify us as soon as practicable.

You must see to it that we receive written notice of the claim or "suit" as soon as practicable.

- c. You and any other involved insured must:
  - (1) immediately send us copies of any demands, notices, summonses or legal papers received in connection with the claim or "suit":
  - (2) authorize us to obtain records and other information:
  - (3) cooperate with us in the investigation or settlement of the claim or defense against the "suit"; and

- (4) assist us, upon our request, in the enforcement of any right against any person or organization which may be liable to the Insured because of injury or damage to which this insurance may also apply.
- d. No insured will, except at the Insured's own cost, voluntarily make a payment, assume any obligation, or incur any expense, other than for first aid, without our consent.

Knowledge of an "occurrence", claim or "suit" by the agent, servant or employee of any insured shall not in itself constitute knowledge of the Insured unless an officer or his designee shall have received notice from its agent, servant or employee.

Item 4. - Other Insurance is deleted in its entirety and replaced by the following:

#### 4. Other Insurance

a. If other valid and collectible insurance is available to the Insured for a loss we cover under Coverage A or B of this Coverage Part, our obligations are limited as follows:

#### (1) Primary Insurance

This insurance is primary except when (2) below applies. If this insurance is primary, our obligations are not affected unless any of the other insurance is also primary. Then, we will share with all that other insurance by the method described in (3) below.

#### (2) Excess Insurance

This insurance is excess over:

- (a) Any of the other insurance, whether primary, excess, contingent or on any other basis:
  - (i) that is Fire, Extended Coverage, Builder's Risk, Installation Risk or similar coverage for "your work";
  - (ii) that is Fire, Lightning, or Explosion insurance for premises rented to you or temporarily occupied by you with permission of the owner;
  - (iii) if the loss arises out of the maintenance or use of aircraft, "autos" or watercraft to the extent not subject to exclusion g. of Coverage A (Section I);
  - (iv) if the loss arises out of "property damage" to borrowed equipment while not being used to perform op-

erations at the job site;

- (v) if the loss arises out of "property damage" due to the use of elevators.
- (b) Any other primary insurance available to you covering liability for damages arising out of the premises or operations, or the product and completed operations, for which you have been added as an insured by attachment of an endorsement.
- (c) Any other primary insurance available to an automatic additional insured when required in a construction agreement you covering liability for damages arising out of the premises or operations unless you are specifically required by written contract for this insurance to be primary.

When this insurance is excess, we will have no duty under Coverage A or B to defend the Insured against any "suit" if any other insurer has a duty to defend the Insured against that "suit." If no other insurer defends, we will undertake to do so, but we

will be entitled to the Insured's rights against all those other insurers.

When this insurance is excess over other insurance, we will pay only our share of the amount of the loss, if any, that exceeds the sum of:

- (a) the total amount that all such other insurance would pay for the loss in the absence of this insurance; and
- (b) the total of all deductible and selfinsured amounts under all that other insurance.

We will share the remaining loss, if any, with any other insurance that is not described in this Excess Insurance provision and was not bought specifically to apply in excess of the Limits of Insurance shown in the Declarations of this Coverage Part.

#### (3) Method of Sharing

If all of the other insurance permits contribution by equal shares, we will follow this method also. Under this approach, each insurer contributes equal amounts until it has paid its applicable Limit of Insurance or none of the loss remains, whichever comes first.

If any of the other insurance does not permit contribution by equal shares, we will

contribute by limits. Under this method, each insurer's share is based on the ratio of its applicable Limit of Insurance to the total applicable Limits of Insurance of all insurers.

#### (4) No Insurance

However, if unintentionally you should fail to disclose all existing hazards at the inception date of your policy, we shall not deny coverage under this Coverage Part because of such failure.

# INSTRUCTIONS FOR PREPARATION OF STATEMENT OF COMPLIANCE

This statement of compliance meets needs of state and federal payroll requirements to pay fringe benefits in addition to payment of the minimum rates. The Contractor's obligation to pay fringe benefits may be met by payment of the fringes to the various pre-approved Plans, funds, or programs or by making these payments directly to the employees as part of their weekly wage payments.

The Contractor shall show on the face of his or her payroll all monies paid to the employees whether as basic rates or total hourly wage amount in lieu of fringes. The Contractor shall report in the statement of compliance that he or she is paying to others fringes required by the Contract and not paid directly to the employees in lieu of fringes. Detailed instructions follow:

#### Contractors who pay all required fringe benefits:

A Contractor who pays fringe benefits to approved Plans, funds, or programs in amounts not less than were determined in the applicable wage decisions shall continue to show on the face of his or her payroll the basic hourly rate and overtime rate paid to his or her employees, just as he or she has always done. Such a Contractor shall check paragraph 4(a) of the statement to indicate that he or she is also paying to approved Plans, funds, or programs within the times required for receipt of those sums not less than the amount predetermined as fringe benefits for each craft. Any exception shall be noted on Section 4(c).

#### Contractors who pay no fringe benefits:

A Contractor who does not pay fringe benefits to an approved Plan shall pay a like amount to the employee. This payment can be reported by inserting in the straight time hourly rate column of his or her payroll an amount not less than the predetermined rate for each classification plus the amount of fringe benefits determined for each classification in the applicable wage decision. Inasmuch as it is not necessary to pay time and a half on wages paid in lieu of fringes, the overtime rate shall be not less than one and one-half the basic predetermined rate plus the required cash in lieu of fringes at the straight time rate. To simplify computation of overtime, the straight time basic rate and payment in lieu of fringes be separately stated in the hourly rate column, thus \$14.56/5.11. In addition, the Contractor shall check paragraph 4(b) of the statement to indicate that he or she is paying fringe benefits directly to his or her employees. Any exceptions shall be noted in Section 4(c).

#### Use of Section 4(c), Exceptions:

Any Contractor who is making payment to approved Plans, funds, or programs in amounts less than the wage determination requires if obligated to pay the deficiency directly to the employees as wages in lieu of fringes.

Any exceptions to Section 4(a) and 4(b), whichever the Contractor may check shall be entered in Section 4(c). Enter in the Exception column the craft and enter in the Explanation column the hourly amount paid the employees as wages in lieu of fringes and the hourly amount paid to Plans, funds, or programs as fringes.

# CITY OF SALINAS PUBLIC WORKS DEPARTMENT

### LANDSCAPE SERVICES FOR NORTH/EAST MAINTENANCE DISTRICT

### SECTION 1 SPECIFICATIONS

All work to be done under this Contract shall conform to the applicable requirements of the STANDARD SPECIFICATIONS DESIGN STANDARDS AND STANDARD PLANS, 2008 Edition, City of Salinas, Public Works Department, herein referred to as the "Standard Specifications". The State Standard Specifications and Standard Plans, May 2006 Editions, herein referred to respectively as "State Standard Specifications" and "State Standard Plans", shall be used.

In the event of conflict between the Specifications and these Special Provisions, the latter shall take precedence over and be used in lieu of such conflicting portions. The listing of certain salient sections from the Standard Specifications and these Special Provisions shall not in any way relieve the Contractor of complying with each and every section of the Standard Specifications.

Wherever in the Special Provisions, Notice to Bidders, Proposal, Contract, or other Contract documents the following terms are used; the intent and meaning shall be interpreted as follows:

State - City of Salinas

Department of Transportation - City of Salinas

Director - City of Salinas

Division of Highways - City of Salinas

**Engineer - City Engineer** 

Local Public Agency - City of Salinas

Owner - City of Salinas

### **SECTION 2** PROPOSAL REQUIREMENTS AND CONDITIONS

### 2-1.01 GENERAL

The Bidder shall examine carefully the site of work contemplated, the specifications, and the proposal and contract forms therefor. The submission of a bid shall be conclusive evidence that the bidder has investigated and is satisfied as the conditions to be encountered, as to the character, quality, and scope of work to be performed, the qualities of materials to be furnished, and as to the requirements of the proposal, plans, specifications, and the contract.

The Specifications are general information only and are for outlining the limits of work and showing the general layout of the existing landscape. It shall be the Contractor's responsibility to verify the amounts of trees, lawn, shrubs, and other items/areas to be maintained. Discrepancies between the plans and items in the field shall be brought to the attention of the Engineer. Additional payment for said discrepancies shall not be allowed.

The Bidder's attention is directed to the provisions in Section 2, "Proposal Requirements and Conditions," of the Standard Specifications and these Special Provisions for the requirements and conditions which he must observe in the preparations of the proposal form and the submission of the bid.

### **Deficiency Notice:**

The Contractor is required to correct deficiencies within the time specified by the City of Salinas. If the deficiency is not corrected within the time specified by the City, City labor will be called out to complete the work. Such work shall be done on a force account basis with an additional call out charge of \$75.00 per hour for each call-out. Call-out of City forces during off-hours, resulting from improper programming of sprinkler controllers, will be charged to the Contractor at time and a half. It also should be noted that there is a minimum three-hour charge for labor on any call-out.

### 2-1.02 EXAMINATION OF SPECIFICATIONS, CONTRACT AND SITE OF WORK

The Bidder shall examine carefully the site of work contemplated, the Plans and Specifications, and the Proposal and Contract Forms therefore. The submission of a Bid shall be conclusive evidence that the Bidder has investigated and is satisfied as to the conditions to be encountered, as to the character, quality, and scope of work to be performed, the quantities of materials to be furnished, and as to the requirements of the Proposal, Plans, Specifications, and the Contract.

All questions about the meaning or intent of the Contract Documents shall be submitted to the City of Salinas through the project page on the Planet Bids website. Replies will be issued by Addenda electronically on-line through the PlanetBids Vendor Portal website and ONLY to Bidders who are registered Prospective Bidders for this project. Questions received less than 10 calendar days prior to the date of the opening of bids will not be answered. Only questions answered by Addenda will be binding. Oral and other interpretations or clarifications will be without legal effect.

Bidder is cautioned to make such independent investigation and examination as he/she deems necessary to satisfy himself/herself as to conditions to be encountered in the performance of the work and with respect to possible local material sources, the quality, and quantity of material available from such property, and the type and extent of processing that may be required in order to produce material conforming to the requirements of these Special Provisions.

The availability or use of information described within the Provisions in Section 2-1.01 is not to be construed in any way as a waiver of the Provisions of the first paragraph of the State Standard Specification in Section 2-1.01 of these Special Provisions, and the Bidder is cautioned to make such independent investigation and examination as he/she deems necessary to satisfy himself/herself as to conditions to be encountered in the performance of the work and with respect to possible local material sources, the quality, and quantity of material available from such property and the type and extent of processing that may be required in order to produce material conforming to the requirements of these Special Provisions.

No information derived from inspection of records of investigation or compilation thereof made by the City of Salinas or from the City Engineer, or his/her assistants, shall in any way relieve the Bidder or Contractor from any risk or from properly fulfilling the terms of the Contract.

### 2-1.03 UNSCHEDULED / EXTRA WORK RATES

Contractor is to furnish the City of Salinas, hourly rates for unscheduled landscape maintenance work, in accordance with the following specifications and provisions.

All unscheduled work shall have prior authorization of the City. Unscheduled work is requested on an as-needed basis and the Contractor is not guaranteed all such work in areas where Contractor is currently providing landscape services to the City. The amount of time each unscheduled job may take is subject to negotiation with the City. Rates offered below would be a major determinant in whether unscheduled work will be furnished by the Contractor providing contract services in the same area.

Should unscheduled work not be provided by the Contractor, said Contractor may be required to coordinate with the City and another Contractor of the City's choosing in order to complete unscheduled repairs.

The Inspector may authorize the Contractor to perform additional work, including but not limited to, repairs and replacements when the need for such work arises. Should such repairs or replacements be necessary as a result of Contractor's negligence, Contractor will be responsible for completing such repairs or replacing damaged property at no additional cost to the City.

- A. Contractor may not change the regular maintenance schedule or work force to perform unscheduled/extra work unless authorized by the Inspector.
- B. In order to be considered for extra work projects both in and outside of their contracted site, the Contractor must maintain their landscape maintenance site in a manner that meets or exceeds City Standards for landscape maintenance. In all cases, the Inspector will determine standards.
- C. Prior to performing any additional work, the Contractor shall give a verbal or written estimate of labor and materials to the Inspector. No work shall commence without a verbal or written estimate. Within 48 hours of verbal or written authorization from Inspector, Contractor shall submit a written estimate. Should a lane closure be required for unscheduled work, cost of permit and equipment shall be detailed in the estimate.
- D. Notwithstanding the above authorization, when a condition exists wherein there is imminent danger of injury to the public or damage to property, the Inspector may verbally authorize the work to be performed upon receiving a verbal estimate from the Contractor. No percentage mark-up shall be added to equipment rental fees.
- E. All additional work shall commence on the specified date established and Contractor shall proceed diligently to complete said work within the time allotted. All replacements of plant material or irrigation components shall be the same like and kind as what is missing or needed to be replaced, unless authorized by the Inspector. Contractor is required to submit highlighted copies of receipts for materials purchased. Receipts shall be turned in with contractors invoice for said repair and replacements.
- F. Inspector shall authorize verbally or in writing, any unscheduled work prior to work being done. Contractor will submit a written quote, detailing materials and labor charges used for extra work. The Inspector will generate a work order, which authorizes the contractor to submit an invoice for work performed.

### 2-1.04 BID PROTEST FEE

Bid protests are limited to "Bidders" as defined in the Contract Documents. Any Bid protest must be submitted in writing to the City Clerk before 5:00 p.m. (as determined by the clock in the City Clerk's Office) within 3 working days after Bid opening.

- (a) Any protest of the proposed award of Bid to the Bidder deemed the lowest responsible Bidder must be submitted in writing to the City no later than 5:00 p.m. within 3 working days following the date of the Bid opening. If a Bidder protests more than one Bid, the Bidder shall file a separate protest as to each Bid being protested, complying with this section.
- (b) The initial protest document must contain a complete statement of the basis for the protest. The protest must refer to the specific portion of the document or the specific statute that forms the basis for the protest. The protest must include the name, address, and telephone number of the person representing the protesting party. The protest must be signed and submitted under penalty of perjury.
- (c) The party filing the protest must concurrently transmit a copy of the initial protest document and any attached documentation to the Bidder whose Bid is being protested, as well as to all other parties with a direct financial interest that may be adversely affected by the outcome of the protest. Such parties shall include all other Bidders who appear to have a reasonable prospect of receiving an award depending upon the outcome of the protest. Faxed or emailed copies are acceptable, with confirmation of receipt by the Bidder or person to whom it was sent.
- (d) The protestor must have actually submitted a Bid on the project or have been specifically excluded from submitting a Bid due to an action by the City. A Subcontractor of a party submitting a Bid on this project may not submit a Bid protest. A party may not rely on the Bid protest submitted by another Bidder, but must timely pursue its own protest.
- (e) The City Council shall hear the Bid protest prior to adopting a resolution authorizing the Bid award and execution of the contract. In cases where the contract is not executed by the City pursuant to City Council Resolution, the Bid protest shall be heard by the City Council prior to the time the City issues a Notice to Proceed or the appropriate City official executes the contract on behalf of the City. The decision of the Council shall be final.
- (f) The protestor shall also submit a non-refundable fee of \$\sum\_{1,000.00}\$ per protest via certified check made payable to the City of Salinas to reimburse its costs in reviewing and investigating the Bid protest. Any protest submitted without the fee shall be returned without further action by the City.
- (g) Any protest not complying with this section shall be returned without further action by the City.
- (h) The procedure and time limits set forth in this paragraph are mandatory, are Bidder's sole, and exclusive remedy in the event of Bid protest. Bidder's failure to comply with these procedures shall constitute a waiver of any right to further pursue the Bid protest, including filing a Government Code Claim or any legal proceedings.

### SECTION 3 AWARD AND EXECUTION OF CONTRACT

The Contractor's attention is directed to the Provisions in Section 3, "Award and Execution of Contract", of the Standard Specifications and Section 2 the "Proposal Requirements and Conditions", of these Special Provisions for the requirements and conditions concerning award and execution of the Contract.

Certificates of Insurance shall be furnished by the Contractor and shall be returned with the signed Contract and Contract bonds within <u>15 calendar days</u> after receipt. The Notice to Proceed with the work <u>shall not</u> be issued by the City Engineer until all such documents are submitted.

The Contractor shall have <u>15 calendar days</u> immediately following award of Contract (not Notice to Proceed) to furnish materials submittals.

In determining the lowest "responsible" Bidder, consideration shall be given to the general competency of Contractor in regard to the work covered by the Proposal. To this end, each Proposal shall be supported by the "Bidder's Statement of Financial Responsibility, Technical Ability, and Experience" on the form(s) found herein. Failure of the Bidder to provide requested information in a complete and accurate manner shall be considered non-responsive resulting in rejection of the Bid. Additionally, the City of Salinas reserves the right to disqualify or refuse to consider a Proposal if a Bidder is in default for any of the following reasons:

- a) Lack of competency and adequate machinery, plant and other equipment, as revealed by the documents requested
- b) Uncompleted work, which in the judgment of the City Engineer, might hinder or prevent the prompt completion of additional work if awarded
- c) Failure to comply with any regulation of the City of Salinas
- d) Default under previous Contracts.

If awarded, this Contract shall be awarded to the responsible Bidder submitting the lowest Bid who meets the financial and technical requirements. The City of Salinas reserves the right to withhold award of Bid for  $\underline{90}$  calendar days from the Bid opening date.

# SECTION 4 BEGINNING OF WORK, TIME OF COMPLETION, LIQUIDATED DAMAGES AND TEMPORARY SUSPENSION OF WORK

The Contractor's attention is directed to the provisions of Section 8, "Prosecution and Progress,", of the Standard Specifications and the following provisions:

The Contractor shall begin the work during the first week of, and shall perform the work outlined in these special provisions for the maintenance of the area described for a period of **three years (36 months)** from said date. This contract may be renewed for two (2) year, provided the Contractor requested, in writing, **three (3) months** before the expiration date and with the approval of the Director of Public Works.

### **SECTION 5-1 MISCELLANEOUS**

### 5-1.01 LABOR NONDISCRIMINATION

Attention is directed to the following Notice that is required by Chapter 5 of Division 4 of Title 2, California Code of Regulations and the City's Federal Mandated Disadvantage Business Enterprise ("DBE") Program.

## NOTICE OF REQUIREMENT FOR NONDISCRIMINATION PROGRAM (GOV. CODE, SECTION 12990)

Your attention is called to the "Nondiscrimination Clause", set forth in the Provisions in Section 7 1.01A(4), "Labor Nondiscrimination", of the Standard Specifications, which is applicable to all nonexempt State Contracts and Subcontracts, and to the "Standard California Nondiscrimination Construction Contract Specifications" set forth therein. The Specifications are applicable to all nonexempt state construction Contracts and Subcontracts of \$5,000.00 or more.

Furthermore, the prime Contractor or Subcontractor shall not discriminate on the basis of race, color, national origin, or sex in the performance of this Contract. Failure by the Contractor to carry out these requirements is a material breach of this Contract, which may result in the termination of this Contract or such other remedy, as recipient (i.e., the City of Salinas) deems appropriate.

### 5-1.02 WAGE DETERMINATION

All wage scales shall be in accordance with applicable determinations made by the Director of the Department of Industrial Relations ("DIR") of the State of California, as provided by Article 2, Chapter 1, Division 2, Part 7 of the Labor Code of the State of California, commencing with Section 1771. In accordance with Section 1773.2 of the said Labor Code, copies of the aforesaid determinations of the Director of the DIR are available on the website address <a href="http://www.dir.ca.gov/OPRL/DPreWageDetermination.htm">http://www.dir.ca.gov/OPRL/DPreWageDetermination.htm</a> They shall apply to the Construction Contract and all Subcontractors thereunder.

The wage rates determined by the Director of DIR and published in the Department of Transportation publication entitled General Prevailing Wage Rates refer to expiration dates. If the published wage rate does not refer to a predetermined wage rate to be paid after the expiration date, said published rate of wage shall be in effect for the life of this Contract. If the published wage rate refers to a predetermined wage rate to become effective upon expiration of the published wage rate and the predetermined wage rate is on file with the DIR, such predetermined wage rate shall become effective on the date following the expiration date and shall apply to this Contract in the same manner as if it had been published in said publication. If the predetermined wage rate refers to one or more additional expiration dates with additional predetermined wage rates, which expiration dates occur during the life of this Contract, each successive predetermined wage rate shall apply to this Contract on the date following the expiration date of the previous wage rate. If the last of such predetermined wage rates expires during the life of this Contract, such wage rate shall apply to the balance of the Contract.

The "Statement of Compliance" and "Payroll Report" shall be on forms furnished by the City. Reduced copies of the "Statement of Compliance" and "Payroll Report" forms are attached in Part "C" of these Specifications. No other forms shall be accepted.

Additionally, all contractors and subcontractors must furnish certified payroll records directly to the Labor Commissioner (aka Division of Labor Standards Enforcement) on a weekly basis and in the format prescribed by the DIR, which may include electronic submission.

### 5-1.03 <u>ENFORCEMENT OF THE CITY'S LOCAL HIRING ORDINANCE</u> <u>REQUIREMENTS</u>

During the term of the contract, the Contractor and all subcontractor(s) shall submit a completed and signed "Local Hiring Residency Compliance Documentation" form with each weekly prevailing wage statement as required in the plans and specifications of the project. This form will be reviewed by the Residence Inspector for the City and to be compared to the list of employees to assure compliance. If for any reason the contractor needs to hire additional employees or subcontractors, the Residence Inspector will require an additional "Statement of Good Faith for Local Hire" form be prepared, signed, and submitted along with the weekly report.

### 5-1.04 <u>DIR REGISTRATION</u>

A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5. It is not a violation of this section for an unregistered contractor to submit a bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 at the time the contract is awarded.

All Contractors (prime and subs) must possess and maintain such registration with DIR in order to be awarded and to perform work on public works projects. ### 5-1.05 <u>SUBCONTRACTING</u>

Per section 5-1.13 of the 2015 Caltrans Standard Specifications, Prime contractor shall perform work equaling at least 30 percent of the value of the original total bid with your employees and with equipment you own or rent, with or without operators.

### **SECTION 5-2 QUALITY ASSURANCE**

### A. Qualifications:

- 1. Experience: The landscape contractor or maintenance subcontractor shall have a full-time employee assigned to the job as foreman for the duration of the contract. He/she shall have a minimum of four (4) years experience in landscape maintenance supervision, with experience or training in turf management, entomology, pest control, soils, fertilizers and plant identification. All tree related work shall be supervised by a Qualified Applicator Certificate holder. All pesticide recommendations shall be made by a Pest Control Advisor.
- Labor Force: The landscape maintenance labor force shall be thoroughly familiar with, and trained in the work to be accomplished and shall perform the task in a competent, efficient manner acceptable to the City.

The Contractor must have a full-time employee who can competently work on irrigation systems, including the testing, rebuilding and/or replacement of valves, controllers and main irrigation line breaks.

It is the Contractor's responsibility, without further direction from the Inspector (except as specified herein), to assure all work is being done per specifications. Contractor shall inspect every site once per day at a minimum, regardless of minimum requirements stated on the Maintenance Performance Schedule.

- 3. The Contractor will be required to have a twenty-four (24) hour emergency phone number where he/she can be reached with no more than fifteen (15) minute delay in call back time. Once notified, contractor shall respond to an emergency within thirty (30) minutes. Contractor is further required to have an active email address, to receive any correspondence from the Inspector.
- 4. Contractor shall not work or perform any operations, particularly during periods of inclement weather, which may destroy or damage ground cover, athletic/turf areas, trees or shrubs. Any debris or litter which collects as a result of inclement weather or flooding, shall be removed during the next scheduled service day.
- 5. Contractor must have office within the City of Salinas.
- 6. Contractor must provide the following organizational information:
  - a) Organization Chart inclusive of executives and descending to on-site crew leader.
  - b) Brief description of company personnel and training procedures.
  - c) The Contractor shall provide a qualified, English speaking/writing crew leader or supervisor to oversee workforce.
    - A listing of guaranteed size of work force by job classification shall be provided to the City prior to beginning work.
- 7. PROJECT/SITE CONDITIONS- At the beginning of the maintenance period, the City's designated representative and the Contractor shall visit the site and walk it to clarify the scope of work and understand existing project and site conditions. Documentation of the general conditions of all plant materials shall be made to determine which are healthy, damaged, dead or dying. Documentation of the general condition of the irrigation system shall be completed to make sure that faulty electrical valves, controllers and broken or inoperable sprinkler heads are reported.

### B. Personal Attire and Equipment

- 1. The Contractor shall require each of his employees to adhere to basic Public Works standards of working attire. This includes uniforms, proper shoes and other gear required by State Safety Regulations, and proper wearing of the clothing. Shirts shall be worn at all times, buttoned and tucked in. Blue or red colored uniforms are not acceptable.
- 2. Contractor shall display the name of his firm on any vehicles used by the Contractor's employees to carry supplies and equipment. The firm name shall be in letters large enough to be easily legible from a distance of one-hundred (100) feet. All contractor trucks and other vehicles shall be uniform in color scheme and paint. All vehicles and equipment shall be in good condition and appearance. All vehicles will display a sign on the vehicle while working on City areas indicating the contractor is under contract with the City. This sign shall be visible at all times.

- 3. Contractor shall be aware of and shall comply with all City ordinances governing landscape maintenance work as applicable to individual locations being maintained.
- 4. It shall be the Contractor's responsibility to supply all safety equipment and to educate their employees in the rules of safety. Safety vests are to be worn at all times while working on City property.

### 5. Requirements

1,

- a) Supervision: The foreman shall directly supervise the work force at all times. Notify City of all changes in supervision.
- b) Identification: Provide proper identification at all times for landscape maintenance firm's vehicles and labor force.

### C. Public Convenience and Safety

- Contractor acknowledges and agrees that public safety is of utmost importance, and Contractor agrees
  that during the progress of the Work, Contractor shall constantly protect and preserve the safety of the
  public.
- Contractor shall not unnecessarily cause inconvenience to the public during the progress of the Work and shall minimize the inconvenience caused by Contractor's operations. Such operations include, but are not limited to, work performed on or adjacent to the Work site, traffic lane and pedestrian closures and deliveries of material and equipment.
- 3. If a scheduled service day falls on a Federal, State or City holiday, Contractor must provide scheduled service within two days before or after the holiday.
- 4. Where public safety is affected, the Contractor shall make immediate equipment repairs or removals of landscape and irrigation material and shall report such repairs or removals within 24- hours to the Maintenance Operations Manager or designee
- 5. Safety provisions shall conform to Cal-OSHA Safety Orders, and all other applicable federal, state, county, and local laws, ordinances, codes, and regulations in performing the work under this Contract. Where any of these are in conflict, the more stringent requirement shall be followed. The Contractor's failure to thoroughly familiarize itself with the aforementioned safety provisions shall not relieve it from compliance with the obligations and penalties set forth therein. The Contractor shall develop and maintain for the duration of the Contract, a safety program that will effectively incorporate and implement all required safety provisions. The Contractor shall appoint an employee who is qualified and authorized to supervise and enforce compliance with the safety program
- 6. <u>Signage</u> The Contractor shall furnish and install all safety street signs, cones, and other facilities, which are necessary to expedite the passage of public traffic through or around the work. This is to prevent accidents, damage, or injury to the public, and to give adequate warning to vehicle or pedestrian traffic or to the public of any dangerous conditions to be encountered.
- Sound Control Requirements The Contractor shall comply with all local sound control and noise level rules, regulations and ordinances which apply to any work performed pursuant to the Contract.

Each internal combustion engine, used for any purpose on the job or related to the job, shall be equipped with a muffler of a type recommended by the manufacturer. No internal combustion engine shall be operated on the project without said muffler.

### **SECTION 5-3 PAYMENT**

### PROMPT PROGRESS PAYMENT TO SUBCONTRACTORS

A prime Contractor or Subcontractor shall pay any Subcontractor not later than <u>7 calendar days</u> of receipt of each progress payment in accordance with the Provision in Section 7108.5 of the California Business and Professions Code concerning prompt payment to Subcontractors. The <u>7 calendar days</u> are applicable unless a longer period is agreed to in writing between the Contractor and the City Engineer. Any delay or postponement of payment over <u>30 calendar days</u> may take place only for good cause and with the City Engineer prior written approval. Any violation of Section 7108.5 shall subject the violating Contractor or Subcontractor to the penalties, sanction, and other remedies of that Section. Federal law (49CFR26.29) require than any delay or postponement of payment over <u>30 calendar day</u> of receipt of each payment may take place only for good cause and with the agency's prior written approval. These requirements shall not be construed to limit or impair any contractual, administrative, or judicial remedies otherwise available to the prime Contractor or Subcontractor in the event of a dispute involving late payment or nonpayment by the prime Contractor, deficient subcontract performance, or noncompliance by a Subcontractor. This Provision applies to both Contractors and Subcontractors.

### PROMPT PAYMENT OF FUNDS WITHHELD TO SUBCONTRACTORS

The prime Contractor, or Subcontractor, shall return all monies withheld in retention from a Subcontractor within 30 calendar days after receiving payment for work satisfactorily completed and accepted including incremental acceptances of portions of the Contract work by the City of Salinas. Federal law (49CFR26.29) requires that any delay or postponement of payment over 30 calendar days may take place only for good cause and with the City Engineer prior written approval. Any violation of this provision shall subject the violating prime Contractor or Subcontractor to the penalties, sanctions, and other remedies specified in Section 7108.5 of the Business and Professions Code. These requirements shall not be construed to limit or impair any contractual, administrative, or judicial remedies otherwise available to the prime Contractor or Subcontractor in the event of a dispute involving late payment or nonpayment by the prime Contractor, deficient subcontract performance, or noncompliance by a Subcontractor. This Provision applies to both Contractors and Subcontractors.

### SECTION 5-4 RESPONSIBILITIES AND MAINTAINING TRAFFIC

The Contractor's attention is directed to the Provisions in Section 7-1.01G, "Water Pollution", of the Standard Specifications

The Contractor shall comply with the requirements of CAL-OSHA, the applicable provisions of local, state, and federal regulations governing the project work.

For Traffic Maintenance, the Contractor's attention is directed to Section 7-1.08, "Public Convenience" and 7-1.09, "Flagging Costs", of the Standard Specifications and these Special Provisions. Nothing in these Special Provisions shall be construed as relieving the Contractor from his/her responsibility as provided in said Section 7-1.09. Contractor shall provide delineators for traffic safety:

A. Whenever immediate action is required to prevent impending injury, death, or property damage, and precautions which are the Contractor's responsibility have not been taken and are not expected to be taken, the City may, after reasonable attempts to notify the Contractor, cause such precautions to be taken and shall charge the cost thereof against the Contractor, or may deduct such cost from any amount due or becoming due from the City. City action or inaction under such circumstances shall not be construed as relieving the Contractor of his/her surety from liability.

B. The Contractor shall notify the Police, Fire, Traffic, Monterey-Salinas Transit, Engineering Department of jurisdictional agencies involved, affected property owners and businesses, and news media (radio, TV, newspaper) at least <u>48 hours</u> in advance of any work that will delay traffic. The Contractor shall cooperate with local authorities relative to handling traffic though the area and shall make his/her own arrangements relative to keeping the working area clear of parked vehicles.

The Contractor shall also be responsible for compliance with additional public safety requirements which may arise during construction. He/she shall exercise special caution against dangerous conditions, and shall provide, install, and maintain temporary barricades and fencing as may be necessary to protect the public. All construction traffic control devices shall be in place and operational prior to beginning work or different phases throughout the contract. Within the area of work barricades, signs, lights, flashers, and other safety devices shall be used by the Contractor to direct vehicular and pedestrian traffic. During any day between 9:00 a.m. and 3:30 p.m., the Contractor may limit traffic to one lane in each direction with approved traffic control measures, unless otherwise directed by the City Engineer.

Within the area of work barricades, signs, lights, flashers and other safety devices shall be used by the Contractor to direct vehicular and pedestrian traffic. Unless otherwise directed by the City Engineer, the Contractor shall maintain pedestrian and two-way vehicular traffic on the streets at all times. Closing of any streets will not be allowed. Traffic safety devices shall be in good repair at all times. Traffic safety devices in need of repair or paint shall be removed immediately from the project on order of the Project Inspector. Upon completion of work, the Contractor shall promptly remove all signs and warning devices.

C. The Contractor's special attention is directed to Section 10 of the Standard Specifications regarding dust control requirements. The Contractor shall abate dust nuisance by cleaning, sweeping, and sprinkling with water or other means as necessary during all phases of construction including weekends, holidays, and any other times as necessary. No mud or cement slurry resulting from saw cutting is to be washed into catch basins. Cleanup expenses to the City at job site due to the Contractor's failure to comply with the Provisions in the Standard Specifications and these Special Provisions will be charged to the Contractor. The use of water which may result in mud on public streets will not be permitted as substitute for sweeping or other materials. Payment for dust control shall be considered as included in the various pay items and no additional compensation shall be allowed therefore.

Personal vehicles of the Contractor's employees shall not be parked on the traveled way or shoulders, including any section closed to public traffic.

Whenever vehicles or equipment are parked within six feet of a traffic lane, the shoulder area shall be closed with florescent traffic cones or portable delineators place on a taper in advance of the parked

vehicles or equipment and along the roadway at 25-foot intervals to a point not less than 25 feet past the last vehicles or piece of equipment. A minimum of 9 cones or portable delineators shall be used for the taper. A C23 (Road Work Ahead) or C24 (Shoulder Work Ahead) sign shall be mounted on a telescoping flag tree with flags. The flag tree shall be place where as directed by the City Engineer.

All traffic cones used on the project shall conform to the requirements for fluorescent traffic cones in said Section 7-1.092. The top of fluorescent traffic cones used in the work during the hours of darkness as defined in Division 1, Section 280, of the California Vehicle Code, shall be covered by a 7-inch flexible vinyl reflective cone sleeve. The Provisions in Section 7-1.095, "Flagging Costs", of the Standard Specifications are amended to provide that the entire cost of furnishing all flagmen will be borne by the Contractor.

Where work is to be performed on private properties (removal and construction of walks, driveway, etc.), the City Engineer will obtain written permission for right-of-entry from the respective owner prior to performing the work. No work shall be commenced by the Contractor until such permission has been granted and until notified by the City Engineer. The Contractor shall be responsible for any and all property damage and public liability resulting from his/her operation on said private properties.

- D. Unless otherwise directed by the City Engineer, the Contractor shall at all times maintain vehicular and pedestrian access to all properties fronting City streets. The Resident City Engineer shall determine if temporary driveways will be necessary within the limits of work during construction. Traffic shall be maintained on one-half of the street at all times. The Contractor's special attention is directed to Section 10 of the Standard Specifications regarding dust control requirements. The Contractor shall abate dust nuisance by cleaning, sweeping, and sprinkling with water or other means as necessary during all phases of construction including weekends, holidays, and any other times as necessary. Cleanup expenses to the City at various job sites due to the Contractor's failure to comply with the Provisions in the Standard Specifications and these Special Provisions will be charged to the Contractor. The use of water which may result in mud on public streets will not be permitted as substitute for sweeping or other materials. Payment for dust control shall be considered as included in the various pay items and no additional compensation shall be allowed therefore.
- E. The Contractor shall provide necessary safeguards and shall exercise caution against injury or defacement of any existing site improvements and plantings. The Contractor shall be responsible for any damage resulting from his/her operations and shall repair or replace such damage at his/her own expense. No trucks or vehicles of any kind shall be allowed to pass over area unless adequate protection is provided. Unless designated otherwise, all existing improvements shall be repaired or replaced, in kind, at the Contractors expense.

Temporary ramps, backfill, or covers for incomplete trenching/backfill operations shall also be furnished by the Contractor at the end of each day's work for the protection of vehicular and pedestrian traffic.

The Contractor shall be responsible for any damage to the work which occurs before final acceptance. He/she is to securely cover all openings into the systems and protect all apparatus, equipment, or appliance, both before and after being set in place, to prevent obstructions in the pipes and breakage, misuse, or disfigurement of the apparatus, equipment, or appliance. Contractor shall be responsible for damage to all existing utilities, whether or not they are indicated on the drawings.

### 7-1.01 MISCELLANEOUS

### 7-1.02 GENERAL

All materials required to complete the work under this Contract shall be furnished by the Contractor except when otherwise specified herein. The City shall have the right to inspect any material specified herein. The items ordered must be designed to comply with all federal, state, and local safety regulations and/or ordinances. Equipment supplies or services that fail to comply with the specifications herein as regards to design, material or workmanship are subject to rejection at the option of the City. Materials rejected shall be immediately removed from the premises at the Contractor's/vendor's expense.

### SECTION 8 BLANK

### **SECTION 9** DESCRIPTION OF PROJECT

The project shall involve the furnishing of all labor, material, equipment, and incidentals to perform the Landscape Maintenance in North East District in accordance with the Plans and these Special Provisions. The maintenance districts are as shown on the location map and described as follows:

### SECTION 9-1 SITE DESCRIPTION

### NORTH-EAST MAINTENANCE DISTRICT

- 1. **Constitution Boulevard** median island and appurtenant strip of land approximately 30 feet in width from face of east and west curb lines including planter walls from East Laurel Drive northerly approximately 10,100 feet to Boronda Road. (Approximately 13.63 acres)
- 2. **Independence Boulevard** median island and appurtenant strip of land approximately 30 feet in width from face of east and west curb lines to Constitution Boulevard northerly approximately 5,700 feet to Boronda Road. (Approximately 7.70 acres)
- 3. **Gabilan Creek** right of way approximately 100 feet in width more or less from a line approximately 3,800 feet northerly of East Laurel Drive, thence 9,200 feet more or less northerly to Boronda Road. (Approximately 20.7 Acres)
- 4. **Nantucket Boulevard** including appurtenant strip of land approximately 30 feet in width from face of north and south curb lines to and including adjacent planter walls from Independence Boulevard easterly approximately 5,000 feet to Constitution Boulevard. (Approximately 6.75 acres)
- 5. **Boronda Road** median island and appurtenant strip of land approximately 30 feet in width from face of north and south curb lines including planter walls from Natividad Road easterly approximately 14,500 feet to Williams Road. (Approximately 19.58 acres)
- 6. Freedom Parkway median island and appurtenant strip of land approximately 30 feet in width from face of north and south curb line including planter walls from Constitution Boulevard easterly approximately 6,800 feet to Williams Road and 6 walkways: to Madrone Drive, Palmera Avenue, Chamise Drive, La Cuesta Court, Cachuma Court, and Eagle Drive. (Approximately 9.18 acres)

- 7. **Nogal Drive** from a line 800 feet south of Freedom Parkway north approximately 1,400 linear feet including appurtenant strip of land approximately 30 feet in width along the east and west curb line to street terminus. (Approximately 1.89 acres)
- 8. **Rider Avenue** including appurtenant strip of land approximately 30 feet in width along the east and west curb line from a location approximately 1,200 linear feet south of Freedom Parkway northerly approximately 3,700 feet to Boronda Road including appurtenant planter walls. (Approximately 5.0 acres)
- 9. **North Sanborn Road** including median island and appurtenant strip of land approximately 30 feet in width from east and west curb lines including planter walls from Del Monte Avenue northerly approximately 4,900 feet to Boronda Road including 3 walkways; to Eagle Drive, Sage Court, and Rockrose Street. (Approximately 6.62 acres
- 10. **Towt Street** from Freedom Parkway westerly approximately 900 linear feet to Mae Avenue including appurtenant strip of land approximately 30 feet in width from curb line of east and west side of roadway including appurtenant planter walls. (Approximately 1.22 acres)
- 11. Williams Road from a line approximately 1,300 feet south of Freedom Parkway northerly approximately 3,500 linear feet to Boronda Road including median islands, 30-foot side strip of land along west curb line including appurtenant planter wall, and 4 walkways: to Cougar Drive, Gaviota Drive, Raven Court, and between Mustang Court and Raven Court. (Approximately 2.36 acres)
- 12. **Buckhorn Drive** from Tamarak Way easterly approximately 2,000 feet to Falcon Drive appurtenant strip of land approximately 30 feet in width from curb line along south side of roadway including appurtenant planter wall. (Approximately 1.35 acres)
- 13. Cul-de-sac Planters (17) at Waterford Circle, Coventry Street, Hyannis Circle, New Salem Drive, New Britain Circle, Burlington Drive, Burlington Circle, Woodbury Circle, Attlebury Circle, Marshfield Circle, Hancock Circle, Suffield Circle, Westfield Circle, Provincetown Circle, Lexington Drive, Canterbury Street, and Boston Circle. (Ap Open Space includes the storm water detention facility, open space bluff and sloping ground areas including all open space easement areas, which have been landscaped and granted to the City of Salinas a permanent open space easement. (Approximately 6.08 acres)
- 14. **Open Space** includes the storm water detention facility, open space bluff and sloping ground areas including all open space easement areas, which have been landscaped and granted to the City of Salinas a permanent open space easement. (Approximately 6.08 acres)
- 15. **Tower Line right-of-way** includes PG&E power line right-of-way from approximately Constitution Boulevard to Boronda Road subsequent to landscaping and granting of open space easement to City of Salinas over lands for public use. (Approximately 6.19 acres) proximately 0.15 acres)
- 16. **Open Space**-between Constitution and the walking path below the apartments and the Professional office building. Nearest the Cal Water Filtration station. Public Easement.
- 17. Las Casitas/Virginia Rocca Barton School-Area below the homes. Behind the Cal Water treatment area towards Twin Creek Golf Course.
- 18. **Twin Creeks Circle**-Area from the curb edge to the furthest side of the sidewalk. Median Landscape.
- 19. **Once a Month Mowing-**This is a non-paved area along the creek. 15 feet from edge of curb clear for pedestrians. From corner of Independence and Constitution towards Lexington Bridge. Second

area from Boronda towards Nantucket before the Apartment Complex trail that leads around the Apartment Complex.

### SECTION 10-1 GENERAL

### 10-1.01 ORDER OF WORK

All work under this project shall be scheduled, coordinated and executed as necessary to meet the frequency of maintenance listed in the proposal within the constraints of the project. All operations shall be coordinated to eliminate any possibility of damage, or unnecessary removal, replacements and/or modifications to existing facilities or to facilities constructed under this project.

### 10-1.02 LEGAL

The Contractor's attention is directed to Section 7 of the State Standard Specifications.

The Contractor shall exercise special caution against dangerous conditions and provide temporary barricades and fencing as may be necessary to protect the public. During construction within the area of work, barricades, signs, lights, flashers, and other safety devices shall be used by the Contractor to direct vehicular and pedestrian traffic.

The Contractor's special attention is directed to Section 10 of the State Standard Specifications regarding dust control requirements.

The Contractor shall provide necessary safeguards and shall exercise caution against injury or defacement of any existing site improvements and plantings. The Contractor shall be responsible for any damage resulting from his/her operations and shall repair or replace such damage at his/her own expense. No trucks or vehicles of any kind shall be allowed to pass over area unless adequate protection is provided. Unless designated otherwise, all existing improvements shall be repaired or replaced, in kind, at the Contractor's expense.

The Contractor is to be responsible for any damage to the work which occurs before final acceptance. He/she is to securely cover all openings into the systems and protect all apparatus, equipment and appliances, both before and after being set in place, to prevent obstructions in the pipes and breakage, misuse or disfigurement of the apparatus, equipment or appliance.

Temporary ramps, backfill, or covers for incomplete trenching/backfill operations shall also be furnished by the Contractor at the end of each day's work for the protection of vehicular and pedestrian traffic.

Unless otherwise directed by the City Engineer, the Contractor shall at all times maintain vehicular and pedestrian access to all properties fronting on City of Salinas streets. **Two-way traffic shall be maintained at all times.** 

### 10-1.03 INSPECTION AND CONTROL OF WORK

The Contractor's attention is directed to Section 5 of the Standard Specifications and Section 5-1.08 of the Special Provisions.

### 10-1.04 FINAL INSPECTION AND CLEANUP

At the completion of the work, a final inspection will be made by the City Engineer. The Contractor will be responsible for final cleanup of the project area in accordance of the Provisions with Section 4-1.02 of the State Standard Specifications.

### 10-1.05 WORKMANSHIP

All work performed under this Contract shall be of the highest quality of the trade and the Contractor shall employ only workers who are skilled and thoroughly familiar with the type of improvements proposed.

### 10-1.06 PROGRESS SCHEDULE

A progress schedule shall be prepared by the Contractor for this Contract and shall conform to the Provisions in Section 8-1.04 "Progress Schedule" of the State Standard Specifications and shall be delivered to the City Engineer at the pre-construction meeting. **No work shall begin until the Progress Schedule has been approved by the City Engineer.** 

### 10-1.07 OBSTRUCTIONS

Attention is directed to Section 8-1.10, "Utility and Non-Highway Facilities," and Section 15, "Existing Highway Facilities", of the State Standard Specifications and these Special Provisions.

### 10-1.08 UTILITY DETERMINATION

The Contractor shall coordinate with the utility companies to locate and mark all utility mains and service laterals, including depth within the project area. Contractor shall make full determination of all underground utilities in order to prevent damage or disruption to the existing services during construction. The Contractor shall Dial 811 to contact the Underground Service Alert ("U.S.A."), , 48 hours in advance before performing any trenching or excavation work.

# <u>Contractor shall adhere to all U.S.A.-North rules and regulations.</u> <u>Contractor shall be responsible for protecting all utility facilities (MH lids, water valves, gas valves, etc.).</u>

The Contractor is hereby notified that some utility conflicts, if any, may exist at the start of construction. The Contractor shall be prepared to schedule his/her work around these conflicts. The utility companies have been advised to work in close cooperation with the Contractor. While the Contractor shall be granted time extensions without penalty for utility delays if such delays impede his/her overall progress, no extra payment will be made for utility delays, except as provided in these Special Provisions. Such time extensions will furnish evidence that his/her overall progress is being delayed. Minor reassignment of work forces or equipment which may be in conflict with utility's work shall not be construed as delay in the Contractor's progress.

Utility company's work, if any, shall be done concurrently with this project and shall include work within the street right-of-way. The Contractor shall schedule and coordinate his/her installations with the utility companies to avoid any conflicts which may impede the overall progress of the project. All removals, installations, and relocations of conflicting underground and above ground utilities shall be executed by the respective utility companies at their expense.

The utilities shown on the Plans are for reference only and are based on utility company records. Known conflicts have been investigated and approximate cover indicated on Plans, if any. The Contractor shall prosecute the work exercising reasonable care not to damage any such facilities. If the Contractor, while performing the

work, discovers facilities not identified on the Plans, he/she shall immediately notify the utility company and the City Engineer in writing within 72 hours.

The Contractor's attention is directed to the existence of certain underground facilities that may require special precautions to be taken by the Contractor to protect the health, safety and welfare of workers and of the public. Facilities requiring special precautions include, but are not limited to: natural gas pipelines, underground telephone, cable TV and electric supply system conductors or cables either directly buried or in duct or conduit. The Contractor shall notify the City Engineer at least <u>24 hours</u> prior to performing any work in the vicinity of such facilities.

Repair of pipes due to accidental or convenience removals (including equipment conflicts) shall be at the expense of the Contractor and no additional compensation will be allowed.

### 10-1.09 EXAMINATION OF SITE

Before submitting a Bid, each Bidder shall carefully examine the Plans and Specifications relating hereto. He/she shall also visit the site of the proposed work and shall fully inform himself/herself as to all the existing conditions relating to the construction and related labor so that he/she may fully understand the facilities, difficulties, restrictions attendant on the execution of the work, limitations applying to the work, and he/she shall estimate and include in his/her Bid a sum sufficient to cover the cost of all items which are required to attain the completed conditions contemplated in the project.

### 10-1.10 WATERING

٠,

Watering, if any, shall conform to the Provisions in Section 17, "Watering" of the Standard Specifications, except that full compensation for developing water supply shall be considered as included in the prices paid for the various Contract items of work involving the use of water and no separate payment will be made. Where applicable, City of Salinas Code Chapter 36A Water Conservation will take priority.

### 10-1.11 CONSTRUCTION EASEMENTS

Any work to be done on private properties or requiring access through private properties **shall not** be done until the City has acquired easements or right-of-entry from the property owner. Prior to starting such work, the Contractor shall verify with the City Engineer that such authority has been granted.

The Contractor will confine his/her operations within the limitations of construction easements or limits as shown on the drawings. If the Contractor's operations result in damage to plantings or any other privately-owned facility outside the limitations of the construction easements or public right-of-way, the Contractor shall, at his/her expense, repair such damage or indemnify the owner of the damaged property.

If the Contractor negotiates with property owners for use of land for construction operations outside the limits of the construction easements, he/she shall do so at his/her own risk and the City will assume no liability for such use of private property. All agreements between the Contractor and private property owners shall be in writing. The Contractor shall commence no work outside the construction easements until copies of such agreements are furnished to the City.

### 10-1.12 PARTIAL PAYMENTS AND RETENTION

The Contractor's attention is directed to Section 9-1.06 Partial Payments of the Standard Specifications.

The Contractor shall submit Subcontractor and/or supplier's waiver of liens as required under Civil Code Article 8122-8138. The waiver shall be "conditional" before payment and "unconditional" after payment on forms set forth in the statute.

As provided in Section 22300 of the Public Contract Code and Section 10263 of the Government Code, Contractor may request that any retention to be withheld during the course of a project is paid to an escrow agent at the Contractor's expense. Should the Contractor make such request, it will be required that an appropriate Escrow Agreement as provided in said government codes be fully executed prior to any payment of retention withheld or to be withheld. The City Engineer or his/her delegate is authorized to execute said Escrow Agreement on behalf of the City.

### 10-1.13 ARBITRATION

Your attention is directed to Section 9-1.22 "Arbitration," of the Standard Specifications. In the event of a dispute as to whether the conditions materially differ or do involve hazardous waste, the Contractor shall continue to proceed with all work to be performed under the Contract and shall retain all rights provided either by Contract or by law which pertain to the resolution of any dispute or protest.

Arbitration shall be initiated by a Complaint in Arbitration made in compliance with the requirements of said regulations. A Complaint in Arbitration by the Contractor shall be made not later than <u>180 calendar days</u> after the date of service in person or by mail on the Contractor of the final written decision by the Department of the claim.

### 10-1.14 NOTICE OF POTENTIAL CLAIM

Section 9-1.04 "Notice of Potential Claim", of the Standard Specifications is amended to read:

Section 9-1.04 Notice of Potential Claim – The Contractor shall not be entitled to the payment of any additional compensation for any act, or failure to act, by the City Engineer, including failure or refusal to issue a change order, or for the happening of any event, thing, occurrence, or other cause, unless he/she shall have given the City Engineer due written notice of potential claim as hereinafter specified. Compliance with this section shall not be a prerequisite as to matters within the scope of the protest Provisions in Section 4-1.03, "Changes", or Section 8-1.06, "Time of Completion", or the notice Provisions in Section 5-1.116, "Differing Site Conditions", or Section 8-1.07, "Liquidated Damages", or Section 8-1.10, "Utility and Non-Highway Facilities", nor to any claim which is based on difference in measurements or errors of computation as to Contract quantities.

The written notice of potential claim shall be submitted to the City Engineer prior to the time that the Contractor performs the work giving rise to the potential claim for additional compensation, if based on an act or failure to act by the City Engineer, or in all other cases within <u>15 calendar days</u> after the happening of the event, things, occurrence, or other cause, giving rise to the potential claim.

It is the intention of this section that differences between the parties arising under and by virtue of the Contract are brought to the attention of the City Engineer at the earliest possible time in order that such matters may be settled, if possible, or other appropriate action promptly taken. The Contractor hereby agrees that he/she shall have no right to additional compensation for any

claim that may be based on such act, failure to act, event, thing or occurrence for which no written notice of potential claim as herein required was filed.

Should the Contractor, in connection with or subsequent to the assertion of a potential claim, request inspection and copying of documents or records in the possession of the City that pertain to the potential claim, Contractor shall make its records of the project, as deemed by the City to be pertinent to the potential claim, available to the City for inspection and copying.

Submission of a claim, properly certified, with all required supporting documentation, and written rejection or denial of all or part of the claim by owner, is a condition precedent to any action, proceeding, litigation, suit, or demand for arbitration by Contractor.

### 10-1.15 **CLAIMS**

. .

Submission of a claim, properly certified with all required supporting documentation, and written rejection or denial of all or part of the claim by the City Engineer, is a condition precedent to any action, proceeding, litigation, suitor demand for arbitration by Contractor. The Contractor's attention is directed to Section 9-1.07B "Final Payment and Claims" of the Standard Specifications.

Payment for graffiti, if required, shall be borne by the Contractor, and no additional compensation shall be allowed therefore.

### 10-1.16 PUBLIC CONTRACTS CODE 9204 PUBLIC WORKS PROJECT

Contract Dispute Procedures

Sections 9204(e) and (g) of the California Public Contract Code ("PCC") provides that the text or a summary of PCC 9204, effective January 1, 2017, shall be included in the plans and specifications for any public works projects that may give rise to a claim under this section and that Section 9204 applies to contracts for public works projects entered into on or after January 1, 2017. In accordance therewith, City of Salinas hereby provides notice and includes the statutory text:

### 10-1.17 <u>"9204.</u>

- (a) The Legislature finds and declares that it is in the best interests of the state and its citizens to ensure that all construction business performed on a public works project in the state that is complete and not in dispute is paid in full and in a timely manner.
- (b) Notwithstanding any other law, including, but not limited to, Article 7.1 (commencing with Section 10240) of Chapter 1 of Part 2, Chapter 10 (commencing with Section 19100) of Part 2, and Article 1.5 (commencing with Section 20104) of Chapter 1 of Part 3, this section shall apply to any claim by a contractor in connection with a public works project.
- (c) For purposes of this section:
- (1) "Claim" means a separate demand by a contractor sent by registered mail or certified mail with return receipt requested, for one or more of the following:
- (A) A time extension, including, without limitation, for relief from damages or penalties for delay assessed by a public entity under a contract for a public works project.

- (B) Payment by the public entity of money or damages arising from work done by, or on behalf of, the contractor pursuant to the contract for a public works project and payment for which is not otherwise expressly provided or to which the claimant is not otherwise entitled.
- (C) Payment of an amount that is disputed by the public entity.
- (2) "Contractor" means any type of contractor within the meaning of Chapter 9 (commencing with Section 7000) of Division 3 of the Business and Professions Code who has entered into a direct contract with a public entity for a public works project.
- (3) (A) "Public entity" means, without limitation, except as provided in subparagraph (B), a state agency, department, office, division, bureau, board, or commission, the California State University, the University of California, a city, including a charter city, county, including a charter county, city and county, including a charter city and county, district, special district, public authority, political subdivision, public corporation, or nonprofit transit corporation wholly owned by a public agency and formed to carry out the purposes of the public agency.
- (B) "Public entity" shall not include the following:
- (i) The Department of Water Resources as to any project under the jurisdiction of that department.
- (ii) The Department of Transportation as to any project under the jurisdiction of that department.
- (iii) The Department of Parks and Recreation as to any project under the jurisdiction of that department.
- (iv) The Department of Corrections and Rehabilitation with respect to any project under its jurisdiction pursuant to Chapter 11 (commencing with Section 7000) of Title 7 of Part 3 of the Penal Code.
- (v) The Military Department as to any project under the jurisdiction of that department.
- (vi) The Department of General Services as to all other projects.
- (vii) The High-Speed Rail Authority.
- (4) "Public works project" means the erection, construction, alteration, repair, or improvement of any public structure, building, road, or other public improvement of any kind.
- (5) "Subcontractor" means any type of contractor within the meaning of Chapter 9 (commencing with Section 7000) of Division 3 of the Business and Professions Code who either is in direct contract with a contractor or is a lower tier subcontractor.
- (d) (1) (A) Upon receipt of a claim pursuant to this section, the public entity to which the claim applies shall conduct a reasonable review of the claim and, within a period not to exceed 45 days, shall provide the claimant a written statement identifying what portion of the claim is disputed and what portion is undisputed. Upon receipt of a claim, a public entity and a contractor may, by mutual agreement, extend the time period provided in this subdivision.
- (B) The claimant shall furnish reasonable documentation to support the claim.
- (C) If the public entity needs approval from its governing body to provide the claimant a written statement identifying the disputed portion and the undisputed portion of the claim, and the governing body does not meet

within the 45 days or within the mutually agreed to extension of time following receipt of a claim sent by registered mail or certified mail, return receipt requested, the public entity shall have up to three days following the next duly publicly noticed meeting of the governing body after the 45-day period, or extension, expires to provide the claimant a written statement identifying the disputed portion and the undisputed portion.

- (D) Any payment due on an undisputed portion of the claim shall be processed and made within 60 days after the public entity issues its written statement. If the public entity fails to issue a written statement, paragraph (3) shall apply.
- (2) (A) If the claimant disputes the public entity's written response, or if the public entity fails to respond to a claim issued pursuant to this section within the time prescribed, the claimant may demand in writing an informal conference to meet and confer for settlement of the issues in dispute. Upon receipt of a demand in writing sent by registered mail or certified mail, return receipt requested, the public entity shall schedule a meet and confer conference within 30 days for settlement of the dispute.
- (B) Within 10 business days following the conclusion of the meet and confer conference, if the claim or any portion of the claim remains in dispute, the public entity shall provide the claimant a written statement identifying the portion of the claim that remains in dispute and the portion that is undisputed. Any payment due on an undisputed portion of the claim shall be processed and made within 60 days after the public entity issues its written statement. Any disputed portion of the claim, as identified by the contractor in writing, shall be submitted to nonbinding mediation, with the public entity and the claimant sharing the associated costs equally. The public entity and claimant shall mutually agree to a mediator within 10 business days after the disputed portion of the claim has been identified in writing. If the parties cannot agree upon a mediator, each party shall select a mediator and those mediators shall select a qualified neutral third party to mediate with regard to the disputed portion of the claim. Each party shall bear the fees and costs charged by its respective mediator in connection with the selection of the neutral mediator. If mediation is unsuccessful, the parts of the claim remaining in dispute shall be subject to applicable procedures outside this section.
- (C) For purposes of this section, mediation includes any nonbinding process, including, but not limited to, neutral evaluation or a dispute review board, in which an independent third party or board assists the parties in dispute resolution through negotiation or by issuance of an evaluation. Any mediation utilized shall conform to the timeframes in this section.
- (D) Unless otherwise agreed to by the public entity and the contractor in writing, the mediation conducted pursuant to this section shall excuse any further obligation under Section 20104.4 to mediate after litigation has been commenced.
- (E) This section does not preclude a public entity from requiring arbitration of disputes under private arbitration or the Public Works Contract Arbitration Program, if mediation under this section does not resolve the parties' dispute.
- (3) Failure by the public entity to respond to a claim from a contractor within the time periods described in this subdivision or to otherwise meet the time requirements of this section shall result in the claim being deemed rejected in its entirety. A claim that is denied by reason of the public entity's failure to have responded to a claim, or its failure to otherwise meet the time requirements of this section, shall not constitute an adverse finding with regard to the merits of the claim or the responsibility or qualifications of the claimant.
- (4) Amounts not paid in a timely manner as required by this section shall bear interest at 7 percent per annum.

- (5) If a subcontractor or a lower tier subcontractor lacks legal standing to assert a claim against a public entity because privity of contract does not exist, the contractor may present to the public entity a claim on behalf of a subcontractor or lower tier subcontractor. A subcontractor may request in writing, either on his or her own behalf or on behalf of a lower tier subcontractor, that the contractor present a claim for work, which was performed by the subcontractor or by a lower tier subcontractor on behalf of the subcontractor. The subcontractor requesting that the claim be presented to the public entity shall furnish reasonable documentation to support the claim. Within 45 days of receipt of this written request, the contractor shall notify the subcontractor in writing as to whether the contractor presented the claim to the public entity, and if the original contractor did not present the claim, provide the subcontractor with a statement of the reasons for not having done so.
- (e) The text of this section or a summary of it shall be set forth in the plans or specifications for any public works project that may give rise to a claim under this section.
- (f) A waiver of the rights granted by this section is void and contrary to public policy, provided, however, that (1) upon receipt of a claim, the parties may mutually agree to waive, in writing, mediation and proceed directly to the commencement of a civil action or binding arbitration, as applicable; and (2) a public entity may prescribe reasonable change order, claim, and dispute resolution procedures and requirements in addition to the provisions of this section, so long as the contractual provisions do not conflict with or otherwise impair the timeframes and procedures set forth in this section.
- (g) This section applies to contracts entered into on or after January 1, 2017.
- (h) Nothing in this section shall impose liability upon a public entity that makes loans or grants available through a competitive application process, for the failure of an awardee to meet its contractual obligations.
- (i) This section shall remain in effect only until January 1, 2020, and as of that date is repealed, unless a later enacted statute, that is enacted before January 1, 2020, deletes or extends that date."

### 10-1.18 DUST CONTROL

Dust Control shall be as specified in Section 10 of the State Standard Specifications, except as herein modified.

Payment for dust control shall be considered as included in the prices paid for the various Contract items of work as listed in the proposal, and no additional compensation shall be allowed therefore.

### 10-1.19 RECYCLING AND CLEANUP

Throughout all phases of work including suspension of work, and until final acceptance of the project, the Contractor shall keep the work site clean and free from rubbish and debris. Salinas Municipal Code 9-4.1 requires all Construction and Demolition ("C&D") projects within the City to divert at least 50% of the C&D debris and 100% of inert materials generated by the project. All building and demolition project contractors must prepare and submit a C&D Waste Reduction and Recycling Plan prior to commencement of project and a final C&D Waste Reduction and Recycling Report to the City Engineer's Office upon completion of the project. Further information can be found in Part E of this document. A copy of the instructions for preparing a C&D Waste Reduction and Recycling Plan can also be obtained from the City of Salinas Permit Center (65 W. Alisal Street, Salinas, CA 93901).

The Contractor shall also abate dust nuisance by cleaning, sweeping, and sprinkling with water, or other means as necessary. The use of water resulting in mud on public streets **will not** be permitted as a substitute for sweeping or other methods.

Failure of the Contractor to comply with the City Engineer's clean up orders may result in an order to suspend the work until the condition is corrected. **No additional compensation will be allowed as a result of such suspension.** 

### 10-1.20 TRAFFIC CONTROL

### 10-1.21 **GENERAL**

A :

All work shall be in accordance with Part 6 of the California Manual on Uniform Traffic Control Devices ("California MUTCD"), Contractor Shall maintain two-way traffic at all times, unless flaggers are provided to control traffic.

Contractor shall provide all signs, barricades, markers, striping, delineators, lights, and flaggers as required by the City Engineer.

Attention is directed to the California MUTCD. A current copy of the California MUTCD is available for free download via the California DOT website <a href="http://www.dot.ca.gov/hq/traffops/signtech/mutcdsupp/">http://www.dot.ca.gov/hq/traffops/signtech/mutcdsupp/</a>.

All work shall be in accordance with the Provisions in Section 12, "Construction Area Traffic Control Devices"; Section 7-1.08, "Public Convenience"; Section 7-1.09, "Public Safety"; and Section 4-1.04, "Detours", of the Standard Specifications, the Provisions in Chapter 5, "Traffic Controls for Highway Construction", of the CalTrans Traffic Manual. Contractor shall maintain two-way traffic at all times, unless flagman is provided to control traffic.

The Contractor's attention is directed to the Provisions in Section 7-1.08, "Public Convenience", of the Standard Specifications. The Contractor shall provide all signs, barricades, markers, striping, delineators, lights, and flagmen as required by the City Engineer.

The Contractor's attention is directed to the Provisions in Section 7-1.09, "Public Safety", of the Standard Specifications. The Contractor shall provide and install all necessary signs, fences, temporary K railings, barricades, lights, and other devices and take such other protective measures to prevent accidents or damage or injury to the public.

The Contractor's attention is directed to the Provisions in Section 12, "Construction Area Traffic Control Devices", of the Standard Specifications. All signs, lights, barricades, delineators, and other devices used for detouring and traffic control shall conform to the requirements within the Provisions in Section 12-3, "Traffic Devices", of the State Standard Specifications.

The Contractor shall submit an Area Sign Plan and Detour Plan per the State Standard Plans, these Special Provisions, and City of Salinas "Channelization Devices Detail" and "Typical Lane Closure Detail" within Part E of the Special Provisions. The City Engineer prior to the beginning of construction shall approve Sign Plan and Detour Plan.

No streets shall be closed to thru traffic. All streets listed in this Contract shall be resurfaced on half street portions to provide access to thru traffic. No lane closures shall be allowed without an approved Access Plan showing barricading, signing, and necessary detour signing in accordance with the latest edition of the "Manual of Warning Signs, Lights, and Devices for use in Performance of Work Upon Highways" as published by the California Department of Transportation. Arterial streets **shall not** be impacted Monday thru Friday; 7:00-8:30 a.m. and 4:00-6:00 p.m.

The Contractor shall notify local authorities (City of Salinas Police and Fire Departments, Monterey-Salinas Transit, City of Salinas, etc.) and news media (radio, TV, and <u>all</u> local newspapers) of his/her intent to begin work at least <u>5 calendar days</u> before work is begun. The Contractor shall cooperate with local authorities relative to handling traffic through the area and shall make his/her own arrangements relative to keeping the working area clear of parked vehicles.

Payment for all traffic detours and traffic control, including all required temporary construction signs and posts, lights, barricades, delineators, and other devices shall include all labor, materials, tools, equipment, all necessary hardware for signs, and other appurtenances required and shall be considered as included in the prices paid for the various Contract items of work as listed in the Proposal and no additional compensation shall be allowed therefore.

### 10-1.22 CHANGES IN WORK

For work done on a "Time and Materials" basis, the Contractor shall submit all required documents for a specific change within ten (10) calendar days of completing the work.

Outstanding proposals at the end of the project: The Contractor shall submit all outstanding proposals, in the specified format, within ten (10) calendar days of the date established as "Substantial Completion". The City reserves the right to <u>not process</u> any proposals received after that date unless specifically agreed in advance.

### 10-1.23 PRESERVATION OF PROPERTY

The Contractors attention is directed to the Provisions in Section 7-1.11, "Preservation of Property", of the State Standard Specifications, and these Special Provisions.

Existing trees, shrubs, and other plants, that are not to be removed, and are injured or damaged by reason of the Contractor's operations, shall be replaced by the Contractor in accordance with the requirements within the Provisions in Section 20-4.07, "Replacement", of the State Standard Specifications.

Damaged or injured plants shall be removed and disposed of outside the City of Salinas right-of-way in accordance with the Provisions in Section 7-l.13 of the State Standard Specifications. At the option of the Contractor, removed trees and shrubs may be reduced to chips. The chipped material shall be spread within the highway right-of-way at locations designated by the City Engineer.

Replacement planting of injured or damaged trees, shrubs, and other plants, caused by the Contractor/Staff shall be completed not less than <u>20 working days</u> once agreed upon by the Engineer and the Contractor. Replacement trees, shrubs, and other plants shall be watered as necessary to maintain the trees, shrubs, and other plants in a healthy condition.

### 10-1.24 <u>ENVIRONMENTAL/POLLUTION PREVENTION REQUIREMENTS</u>

Contractor shall comply with all environmental pollution prevention regulations, ordinances, and statutes that apply to the project and any work performed pursuant to the contract. Salinas City Code Chapter 29-9 states:

"No person shall contribute or cause to be contributed, directly or indirectly, to the city's storm drainage system any pollutant, wastewater or any substance or material which will interfere with the operation or performance of the storm drainage system, violate the city's NPDES permit or violate other applicable law or regulations."

The Contractor shall comply with the City of Salinas NPDES Permit Order No. R3-2012-0005 and, if applicable, the State's current Construction Stormwater General Permit. Projects that disturb one or more acres of soil, or disturb less than one acre but are part of a larger common plan of development, are required to obtain coverage under the General Permit for Discharges of Stormwater associated with Construction Activity, Construction General Permit Order No. 2012-0006-DWQ.

Construction activity subject to the CGP includes clearing, grading, and disturbances to the ground such as stockpiling or excavation, or construction activities associated with Linear Underground/Overhead Projects ("LUPs"). The City of Salinas NPDES permit also has additional requirements applicable to construction projects of any size.

### 10-1.25 MOBILIZATION

4.

Mobilization shall conform to the Provisions in Section 11, "Mobilization", of the State Standard Specifications.

Payment for mobilization shall be considered as included in the prices paid for the various Contract items of work as listed in the Proposal no additional compensation shall be allowed therefore.

### SECTION 11 LANDCAPE MAINTENANCE

### SECTION 11-1 DEFINITIONS

For the purpose of this contract, the following terms and wordings have definitions hereinafter specified:

**Hand-Sweeping** – Removal of refuse by the use of hand tools including brooms and shovels. Compensation for Hand-Sweeping shall be considered as included in other items of work.

**Refuse** – All deposits of dirt, rock, glass, cans, leaves, sticks, papers, or any like materials so designated by the Engineer within the areas to be swept within the terms of this contract and of a size which can be practically removed by mechanical sweeping or hand-sweeping operations.

Engineer - Engineer of Public Works Department, or designated representative(s), City of Salinas.

City of Salinas BMPs for pesticide, herbicide, and fertilizer application, storage, and disposal, including the following:

- Training activities, permits, certifications, and other measures for municipal applicators and distributors;
- Integrated pest management measures that rely on non-chemical solutions for all municipal areas;
- Eliminating the use of pesticides and fertilizers within **48 hours** prior to a likely precipitation event or irrigation. A likely precipitation event is any weather pattern that is forecast to have a **50 percent or greater** probability of producing precipitation in the application area;
- Collection and proper disposal of unused pesticides, herbicides, and fertilizers;
- A standardized protocol for the routine and non-routine application of pesticides, herbicides (including pre-emergents), and fertilizers;

- Prohibition of storage or application of banned or unregistered pesticides;
- Implementation of procedures to encourage the retention and planting of native vegetation to reduce water, pesticide, herbicide, and fertilizer needs;
- Limiting or replacing pesticide use (e.g., manual weed and insect removal);
- Limiting or eliminating the use of fertilizers. Prohibition fertilizer application within 5 feet of pavement, 25 feet of storm drain inlet, or 50 feet of a water body;
- Reducing mowing of grass to allow for greater pollutant attenuation, but not jeopardizing motorist safety;
- Storage of pesticides and fertilizers indoors or under cover on paved surfaces or use of secondary containment;
- Reduction in the use, storage, and handling of hazardous materials to reduce the potential for spills;
- · Regular inspection of storage areas;
- Prohibition of use of pesticides on the CWA section 303(d) list for any water bodies the Permittee's MS4 is tributary to; and
- Provide direct supervision by a pesticide applicator, certified in the appropriate category, of municipal employees or contractors applying restricted pesticides.
- Contractor shall not use pyrethroid pesticides. Alternate materials should be considered. Utilize BMP's to replace materials/chemicals with more environmentally benign materials or methods (e.g., use mechanical methods rather than herbicides).

### A. Weed Control - General

- At the discretion of the Engineer, weeds in all lawn areas, planting beds, planted islands, tree wells, shrub wells, parking lots, traffic islands, curb and gutters, sidewalks, and open space shall be removed or killed weekly as the weeds emerge. Weeds shall be mechanically removed (not just killed) if they are larger than 2 inches (5 cm) in height or diameter. Unsightly weeds throughout the Districts will be mechanically removed or prevented against throughout all districts.
- 2. All debris resulting from weeding operations shall be removed from the project area on the same day that the weeding operation occurs.
- 3. Should the Contractor desire to use a chemical weed control program, they shall develop said program and submit in writing to the Engineer within 15 days of approval of contract for review and approval. Said program shall be administered in accordance with applicable laws and practices governing the use of chemicals. Said program shall be adhered to unless written approval to change such program is granted by the Engineer Weed oils, granular pellets or any other weed control materials shall be used only in strict conformance with Federal, State, County, and local regulations and codes. The materials must be approved by the Engineer.

- 4. The Contractor or the Pest Control Operator of the Contractor must have a valid certification appropriate to the pesticide application undertaken, and all weed control must have a written recommendation prepared by a Certified Pest Control Advisor, as required by the Monterey County Agriculture Commissioner.
- 5. Any new or existing plants or soil which, in the opinion of the Engineer, have been damaged by applying or lack of applying weed control materials shall be replaced by the Contractor no later than one (1) week after notice of such damage at Contractor's expense.
- 6. Planter Maintenance: Complete trimming and cultivating of planters and ground cover shall be completed monthly. Weeding shall be performed regularly to avoid establishment of seedlings.

All vegetation shall be sprayed and removed for a distance of eighteen (18) inches from tree trunks to form tree wells. Any additional weed control in turf areas shall be as needed or as directed by the Maintenance Operations Manager or designee.

Weed control required and approved within turf areas by the Maintenance Operations Manager or designee is considered as part of contract.

- 7. Handling of Pesticides: Care shall be taken in transferring and mixing of pesticides to prevent contaminating areas outside the target area. Application methods shall be used to which ensure that materials are confined to the target area. Spray tanks containing leftover materials shall not be drained on the site. Disposal of pesticides and tank rinsing materials shall be within the guidelines established in the State of California Food and Agricultural Code or EPA regulations.
- 8. Timing: Pesticides shall be applied at times, which limit the possibility of contamination from climatic or other factors and at the proper life cycle of the pests. Early morning application shall be used when possible to avoid contamination from drift. Applicator shall monitor forecast weather conditions to avoid making application prior to inclement weather to eliminate potential runoff of treated areas
- Contractor shall apply spray chemicals when air currents are still; preventing drifting onto adjacent property and preventing any toxic exposure to persons whether or not they are in, or near, the project.

### B. Insect and Disease Control

1.

- The Contractor or the Operator must have a valid certification appropriate to the pesticide application undertaken, and all weed control must have a written recommendation prepared by a Certified Pest Control Advisor as required by the Department of Pesticide Regulation and the Monterey County Agriculture Commissioner.
- 2. The spray materials shall meet all Federal, State, County, and local requirements. The spray materials must be approved by the Engineer.
- 3. Any applications within 500 feet of any school shall not be made within one hour before or one hour after school hours, as required by applicable pesticide regulations.
- 4. The Contractor shall use a dormant spray fungicide that controls anthracnose and other plant diseases as needed.

- 5. The Contractor shall use an appropriate insecticide and fungicide spray that prevents or controls disease and insect infestations.
- 6. Application of insect and disease control materials shall be within the time best suited to the eradication of the insects and diseases.
- 7. Any new or existing plants or soil which, in the opinion of the Engineer, have been damaged by applying or lack of applying control materials shall be replaced by the Contractor within a week after notice of such damage at his expense.
- 8. Scheduled spraying shall be applied twice annually to all deciduous trees and shrubs. The first spraying shall be accomplished while trees or shrubs are in full dormancy. The second spray shall be applied just as the buds start to open. Contractor's choice of specific spraying times must be approved by the Engineer.
- 9. A program for control of insects and diseases shall be developed by the Contractor and Submitted with supporting manufacturer's data and submitted in writing to the Engineer within 15 days of the approval of the contract for the Engineer's review and approval.
- 10. Pesticides shall be stored, transported and applied only in strict conformance with Federal, State, County, and local regulations and codes. The materials musts be approved by the Engineer in advance of the application.
- 11. If spraying cannot be performed for any reason, the contractor shall use tree injections to control infestations according to pesticide label.
- 12. Irrigation water applied after treatment shall be reduced to eliminate runoff. When water is required to increase pesticide efficiency, it shall be applied only in quantities of which each area is capable of receiving without runoff.
- 13. Contractor shall be responsible to update daily all pesticide, herbicide and fertilization applications to the City's PHF on-line app.

### C. Ground Squirrel, Gopher and Other Rodent Damage Control

Contractor shall repair all rodent damage. All fresh mounds are to be removed and rodents eradicated within four (4) days by the Contractor in planted areas and seven (7) days in non-planted areas. All rodent damage done to turf areas shall be leveled out and re-sodded to match existing grade. All damage done to existing plant material by rodents shall be replaced by contractor with new plant material.

Rodent Control-Contractor shall keep all turf and landscaped areas free of gophers by using Macabee gopher traps or other devices approved by the contract manager. **Rodenticide use is not allowed.** 

### D. Debris, Graffiti and Litter Removal

Areas:

- 1. All debris and litter shall be removed by the Contractor from all project areas within two (2) days (twice a week) of deposit. Debris and litter removal shall be disposed of immediately by Contractor.
- Debris and litter to be removed shall include but is not limited to all debris generated by the work included in this project, paper, glass, trash, leaves, pine needles and all other forms of debris and litter from all sources including those outside the project site.
- 3. Contractor shall remove "graffiti" or other unsightly markings placed upon visible faces including, but not limited to, cinder block walls, bench seats, picnic tables, irrigation/lighting boxes, light poles, tree trunks, sidewalks, and any other surface within the district boundary within the next working day during the term of this contract. Graffiti removal shall be considered as part of regular maintenance activities and shall not be compensated as additional work.
- 4. Complete policing; litter pickup and supplemental hand sweeping of parking lot corners, street medians, storm drain grates and areas along gutters/curbs inaccessible to power equipment shall be accomplished to ensure a neat appearance.
- 5. Contractor shall dump all trash receptacles located throughout the Landscape District. This also includes installing plastic bags as needed, contractor supplied.

### E. Signs/Improvements

Contractor shall not post signs or advertising material upon the site premises unless prior approval is obtained from the Inspector.

Contractor will remove all advertisements and election signs from the work site, including from utility poles and trees, each time site is serviced. Signs shall be stored by contractor until City staff gives approval for their disposal.

### F. Removal of Dead, Damaged, or Diseased Plant Materials

Contractor shall remove dead, severely damaged or diseased plant material no later than seven

(7) days after identification. Broken tree limbs or other items that may cause hazardous conditions to the public shall be removed immediately.

### G. Staking and Guying

- Newly planted trees shall be kept adequately staked at all times. Ties shall be loosened periodically to prevent girdling. A detailed drawing of the staking system to be used is included in Appendix "A", Street Tree Planting Plan.
- 2. Newly planted trees shall not be left unstaked for more than two (2) working days, unless written permission is granted by the Engineer.
- Trees that have reached a size and stability so as not to require staking shall be exempt from these requirements upon the approval of the Engineer. Trees under the size of a standard 5 gallon size for

the variety shall also be exempt from these requirements unless otherwise required by the Engineer.

### H. Inclement Weather

- 1. During the periods when inclement weather hinders normal operations, the Contractor shall adjust his work force in order to accomplish those activities that are not affected by weather.
- 2. The Contractor shall re-stake, re-tie or remove trees or other such activities as required as a result of inclement weather. The Contractor will stay available to assist in any storm related damage repair to sites in this contract.
- Contractor shall not work or perform any operations during inclement weather that may destroy or damage ground cover or turf areas. The Contractor shall contact the Maintenance Operations Manager or designee for the determination of non-operation conditions.
- 4. The Contractor shall immediately notify the Maintenance Operations Manager or designee when the work force has been removed from the job site due to inclement weather or other reasons.

### I. Fire Prevention

Contractor shall take all precautionary measures to insure that while working with (power equipment, vehicles, etc.) in weeded or grassy areas they do not start a fire. All contractor vehicles shall be equipped with fire extinguishers.

The City of Salinas shall not be held liable for any fires due to contractor negligence.

### J. Irrigation of Plant Materials

 All planted areas shall be watered deeply as weather conditions require to promote normal growth and insure the health of the vegetation therein. Water for the irrigation systems shall be furnished by the City. Water usage shall be in accordance with the City's water conservation Ordinance No. 2123. Lawns at no time shall show a lack of fresh green color or a loss of resilience due to a lack of water.

Control watering to prevent runoff and/or erosion, puddling, or over watering. Prevent watering roadways, walkways or private property. Provide adequate coverage of all landscape areas. Match precipitation rates. Limit hazardous conditions. Adjust irrigation as required due to seasonal changes and rain. A current schedule of automatic watering cycles must be provided to the Engineer's representative upon request. Automatic controllers shall be set to operate irrigation systems between 9:00 p.m. and 5:30 a.m., or as directed by the Engineer.

- 2. Emergency irrigation not conforming to the City's Water Conservation Ordinance will require prior approval by the Engineer prior with notification to the water purveyor of the time, location and reason for the non-conforming irrigation.
- 3. All irrigation systems shall be tested and inspected and a written report submitted to the City when requested.

- 4. All irrigation systems shall be tested and inspected as necessary when damage is suspected or observed, or reported daily if necessary.
  - Battery operated controllers will be kept in continuous operating condition by replacing batteries when necessary at Contractor's expense.
- 5. All replacements shall be in strict accordance with City of Salinas equipment and installation standard plans, no substitutions will be permitted.
- 6. Unplug all clogged heads, flush lines free of rocks, mud and debris.
- 7. Contractor shall maintain all irrigation systems in a manner that shall assure correction or malfunction and allow their use in a manual or automatic condition within two (2) working days after identification of malfunction. All valve boxes, valves, vacuum breakers, hydrants, and sprinklers shall be kept clear of debris and vegetation. Contractor is responsible for cost to repair or replace irrigation systems which malfunction due to Contractor's negligence.
- 8. The payment for the repair and maintenance of the irrigation systems shall be considered as included in the monthly price paid for landscape maintenance and no separate payment shall be made therefor. The prices paid shall include full compensation for furnishing all labor, materials, tools, and equipment and doing all work involved as specified. Major irrigation repairs, such as repairing control valves, controllers, vacuum breakers, and backflow preventers, shall not be considered as normal maintenance for the purpose of billing. Contractor shall obtain approval from the City before incurring expenses for major irrigation repairs. Contractor may replace any malfunctioning portion of the irrigation system with the same or a substitute type of product or operation with prior consent of the Engineer.
- 9. Major irrigation repairs, such as replacement of defective remote control valves, major controller repairs, major backflow prevention unit repairs, extensive wiring, repairs to the irrigation mainline, or any other single major irrigation repair project, which necessitates costs for materials in excess of \$150, shall not be considered as normal maintenance for the purpose of billing. Contractor shall obtain approval from the Engineer before incurring expenses for major irrigation repairs.
- 10. In the event of a malfunctioning remote control valve, the Contractor shall be responsible for manual watering by utilizing the use of a water truck or water bubble, hand bleeding remote control valves, setting out additional hoses and sprinklers, and/or hand watering as required to uniformly irrigate affected areas until said valve is repaired.
- 11. Controller enclosures shall be maintained by the Contractor at no extra cost to the City. This maintenance shall include rust removal, painting, sealing, or other measures which are intended to preserve the controller enclosure. Any replacement of the controller box necessitated by vandalism or deterioration, after all reasonable efforts have been made by the contractor to preserve the enclosure will be paid for as extra work.
- 12. Contractor shall keep irrigation controllers securely locked at all times when they are not required to be open for programming, repairs, or checking the operation of the controller.

13. Controllers shall be checked at least weekly to assure proper operation and programming.

### K. Water Conservation

Contractor shall, whenever possible, minimize the use of water during maintenance operations. Watering equipment shall be kept in good working order; water leaks shall be repaired promptly; and washing of equipment, except when necessary for the safety of and for the protection of equipment, shall be discouraged. In no case shall the Contractor use water to rinse or flush chemicals of any kind from equipment onto the work site and/or drainage or sewage systems.

Drought Impact on Irrigation: The Contractor shall comply with all water use regulations and restrictions. In addition, Contractor shall comply with City directed changes in irrigation in response to drought conditions.

### L. Underground Excavations

Contractor shall be responsible for locating all underground utility lines to insure the safety of his/her work crew and to protect in place existing utility equipment before commencing any excavation. Contractor shall contact the Maintenance Operations Manager or designee and Underground Service Alert (1/800-227-2600) 48 hours before commending any excavation, to locate underground service lines.

### M. Fertilizing

The contractor shall provide ten (10) days advance written notice to Engineer of each intended application of fertilizer.

Lawn and All Types of Ground Cover. Commercial fertilizer shall conform to the provisions of Section 20 of the City of Salinas, Standard Specifications Design Standards, 2008. Fertilizer shall be a complete fertilizer, part if the elements of which are derived from organic sources; and shall have a guaranteed analysis of:

Element	Minimum
Nitrogen	16%
Phosphoric Acid	6%
Water Soluble Potash	4%

and shall be applied at such a rate to insure one pound of actual nitrogen per 1,000 square feet of area per application or as approved by the Engineer. Turf fertilizer shall be applied a minimum of three (3) times during the growing season, two (2) times per growing season for other planted areas to maintain healthy, vigorous growing conditions of all plants at all times.

 Trees and Shrubs – Fertilizer tablets shall be 21-gram size with a guaranteed analysis of, or a departmentally approved equivalent product:

Nitrogen	20.00%
Phosphoric Acid	10.00%
Water Soluble Potash	5.00%
Combined Sulfur	1.60%
Iron	0.35%

and shall be applied at the following rate:

One tablet for each one-half inch of tree trunk diameter (tree trunk diameter shall me measured within six inches of the ground line) or three tablets per tree, whichever is greater, inserted up to two feet deep, but not less than 8 inches deep, equidistant round the dripline at the end of March each year.

One tablet for each shrub shall be inserted up to two feet deep, but not less than eight inches deep, near each shrub at the end of March of each year

### N. Tree Work - Shall be considered Extra Work.

Staff - Any personnel engaged in the pruning of City of Salinas urban forest trees must be authorized to do so by the Director or an Urban Forestry designated representative. Prior to pruning please contact the City of Salinas Parks and Forestry Division. All personnel engaged in pruning operations shall do so under the supervision of an International Society of Arboriculture (ISA) Certified Arborist. Prior to approval of any tree pruning operation, it shall be the responsibility of the Contractor to provide the City of Salinas with proof of current ISA Arborist Certification for staff engaged in project supervision. Inspection of project work will be done by Urban Forestry Division staff members, designated by the Director.

- 1. Schedule No tree work shall commence before 7:30 a.m. Crews are prohibited from working beyond dusk.
- 2. Health Maintenance Removal of dead, diseased or hazardous limbs.
- 3. Structural Pruning to maintain the strength and shape.
- 4. Safety Prune to prevent wind damage and protect the public or adjacent property. No tree limbs shall protrude into vehicle roadways or streets below fourteen (14) feet from the ground and no tree limbs shall be less than nine (9) feet from the ground overhanging walkway. Clearance shall be as determined by the Engineer in all other areas.
- 5. General Pruning No "stubbing" cuts shall be allowed. Any deadwood shall be removed to the point of attachment. Final cuts shall be made in such a way as to retain the bark collar without leaving a stub or cutting into the collar. When removing a dead branch, pruning cuts shall be made outside the callus tissue that has begun to form around the branch. All limbs two inches in diameter or over must be precut to prevent splitting. If splitting does occur, the wound shall be traced.
- 6. Crown Thinning Pruning to thin crowns of trees shall be undertaken with the purpose of opening a tree to light, reducing weight on limbs, decreasing the wind sail effect, invigoration of the growth of the tree, and to increase the overall structural stability of the tree. Thinning operations should conform to ISA Standards.

- 7. Crown Reduction Crown reduction shall be completed to reduce the overall height and spread of the trees. The goal of this pruning operation is to enhance the structural integrity of the trees designated for the pruning operations. No tree shall have more than 1/3 of the canopy removed in this pruning operation without prior approval of the City Engineer or the designated Urban Forestry staff representative. All crown reduction shall be performed in conformance with the ISA Pruning Standards included as Appendix A.
- 8. Crown Restoration Structural integrity shall be enhanced through crown restoration pruning. A natural appearing crown shall be developed through pruning which is done to a lateral to control the tree's growth to wood which is securely attached to healthy wood. It is anticipated that this process is one which requires an initial pruning with additional follow-up prunings to direct and accomplish a complete crown restoration project. All crown reduction—shall be performed in conformance with the ISA Pruning Standards.
- 9. Clearance Pruning Limbs growing in the direction of adjacent structures shall be pruned to minimize conflict with the structures (i.e. street signs). Lower limbs, suckers, and hanging foliage shall be raised to approximately Fourteen (14) above the street for traffic clearance, and 9 feet above sidewalks and lawns for pedestrian access. Deviation from clearance height requires approval of the Public Works Engineer or designated Urban Forestry staff representative. Immature specimens may require an adjustment appropriate to the individual tree size and stage of growth.

### 10. Miscellaneous

- a. Pruning sealant or paint is not required, or allowed, on pruning cuts.
- b. Trees which are infected with a disease shall require removal of all infected limbs to a point in the limb at least 6 inches below the diseased area. Any tree found to be fully infected with a disease shall be inspected by the designated Urban Forestry staff member prior to any pruning which would reduce the size of the infected tree substantially or require removal of the tree.
- c. Height Prune to specific height as directed by the Engineer.

### O. Hedge Trimming

1. All hedge and ground cover plants growing in the subject areas shall be trimmed and pruned, to maintain plants in a healthy, growing condition and to maintain plant growth, within reasonable bounds as determined by the Engineer, and to maintain uniform height to prevent encroachment of passageways, walks and streets, and to provide adequate view of signs and vision for vehicular traffic. Dead or damaged limbs or branches, trees or shrubs shall be removed immediately and all pruning cuts shall be made cleanly with sharp pruning or hedging tools with no projections or stubs remaining. All cuttings, branches, and leaves shall be removed and disposed of before the end of the work day. Traffic signs, cones, etc., shall be used in accordance with City Standards.

### 2. Site Clean-Up

a. Disposal – All disposal of material generated from the pruning operations is the sole responsibility of the Contractor engaged in the operation. This shall include wood, foliage, and other organic material. Dust and dirt shall be kept to a minimum during the pruning process and shall be removed at the end of each day's operations or at the completion of work at individual sites prior to the Contractor leaving the site. No wood shall be left at the site of work unless prior approval of the Engineer or designated representative has been obtained. The costs of disposal of all wood and other debris generated by the project is included in the cost of the project costs and shall not be declared as additional costs to the project.

- 3. Signage The Contractor shall furnish and install all safety street signs, cones, and other facilities, which are necessary to expedite the passage of public traffic through or around the work. This is to prevent accidents, damage, or injury to the public, and to give adequate warning to vehicle or pedestrian traffic or to the public of any dangerous conditions to be encountered.
- 4. Sound Control Requirement The Contractor shall comply with all local sound control and noise level rules, regulations, and ordinances which apply to any work performed pursuant to the Contract.

### P. Trimming Edging

- All lawns shall be trimmed and edged around irrigation systems, fire hydrants, tree wells, shrub basins, along ground cover, and curbs/sidewalks every week from March through October and every month from November through February.
- 2. Grass shall be trimmed around sprinkler heads as necessary to provide the maximum water coverage of spray nozzles. Removal of turf from around sprinkler heads will not be permitted.
- 3. Damage to sprinklers, headers, irrigation and utility boxes, and other structures shall be avoided. All damage to shall be reported to the Engineer's representative and contractor shall make repairs promptly.
  - All debris generated by edging shall be removed from the project site by the end of the working day. All trimming and debris shall be raked from all planted and unplanted areas and shall be disposed of off-site by the Contractor. Costs for same are to be included in the routine maintenance fee.
- 4. All ground cover shall be trimmed to the inside edge of planting areas when ground cover grows three inches outside planting areas.

Contractor shall exercise care not to spray tree trunks with any chemicals or injure the tree trunk with any chemicals or injure the tree trunks with mechanical equipment. Trim lawn edges or tree wells with power edgers or by hand, but in no case will soil sterilents be permitted.

### Q. Mowing

- 1. Ground cover plants other than lawns, e.g. ivy, hypericum, etc., shall be mowed once each year in the appropriate season to a height of three inches from ground level.
  - Ground cover plants shall be edged along curbs and planter edges so that no more than 4" of growth extends beyond the planter areas.
- 2. Lawn area shall be mowed at 2" height once every week from March through October; once every other week from November through February.

- 3. Lawns shall be renovated yearly by aerating and/or verti cutting. This shall be done during the spring. If required for optimum water penetration, repeat as needed. Reseed bare areas as needed.
- 4. All mowing equipment shall be kept in good repair with cutting surfaces sharpened to ensure a clean and effective cutting of grass blades.
- 5. All moving equipment shall be free of leaking fluids which would adversely affect the health of turf or other surfaces within the areas of responsibility.

The Contractor shall submit a mowing schedule of days and times for each designated park and landscape site. The Contractor shall maintain the schedule as closely as possible unless a change is authorized or directed by the Maintenance Operations Manager or designee. Should weather or site conditions prove to be prohibitive to the regularly scheduled mowing, Contractor shall contact the Engineer to reschedule the mowing service to a time and date acceptable to the Engineer. The Contractor shall not be compensated for mowing services which have not been provided, either through a regularly scheduled mowing or an acceptable rescheduled dated approved in advance by the Engineer.

In case of equipment failure Contractor shall notify the inspector of the failure immediately and reschedule that week's service to be completed within two days of said failure upon approval of Inspector.

Turf clippings and debris shall be lifted the same day of each mowing, trimming or edging operation and shall be removed from each district and landscape site. The use of mulching mower blades is acceptable as long as large amounts turf clippings are not impeding on normal turf growth.

### R. Hauling

- 1. Spillage resulting from hauling operations on or across public thoroughfares shall be immediately removed at Contractor's expense.
- 2. If the spillage is of a hazardous substance, such as petroleum products, or pesticides, Contractor is required to contact the Maintenance Operations Manager or designee immediately and also prevent the substance from running into storm drains.

### S. Playground inspections

Contractor shall perform daily, weekly and monthly playground inspections:

- Daily-This includes checking for broken glass, graffiti, trash, or other foreign objects. Empty all trash receptacles. Check playground for major hazards. Daily cleaning of barbecue pits including emptying ash pales.
- 2. Weekly-Playgrounds with loose fill surfacing shall have minimum of 12 inches of fill placed under all swings, slides and major play equipment. Keep play area free of vegetation. (No Pesticides or Herbicides allowed in play area.)
- 3. Monthly- Check all play structures: Footings (loose, cracked), All moving parts for wear, rust, broken or missing parts (s-hooks, grommets, chains), and vandalism. Check all handrails, floors, steps, fasteners for excessive wear or damage.
- 4. Contractor shall be responsible to secure broken equipment until replacement or repair is completed.
- 5. Contractor shall report any findings immediately to Engineer.

Contractor shall supply daily, weekly and monthly inspection reports (checklist) to the City at the end
of each month for each individual playground. This also includes exercise equipment and horseshoe
pits areas.

### SECTION 11-2 HAULING

1 .

The payment for hauling shall be considered included in the various items of work, and no additional compensation will be allowed therefore.

### SECTION 11-3 UNSUITABLE MATERIAL

The excavation and removal of additional unsuitable materials beyond the depths of excavations at site, and additional backfill, if required by the City Engineer, shall be in accordance with Section 19-2.02 of the Standard Specifications.

### **SECTION 11-4 PAYMENT**

Payment for Excavation shall be as included in the various items of work and shall include: Compaction of native soil, disposal and all other work necessary except unsuitable material to attain the completed conditions contemplated in this project shall be included under the various items of work in the Proposal, and no additional compensation shall be allowed therefore. Unsuitable Material shall be paid for under Section 19-2.02 of the Standard Specifications. Hauling of excavated materials shall be as included in the Contract price paid for various items of work listed in the Proposal, and no additional compensation shall be allowed therefore.

### **SECTION 12** TEMPORARY TRAFFIC SIGNAGE

### **SECTION 12-1 GENERAL**

All work and materials for signs shall conform to the Provisions in Section 56 of the Standard Specifications, these Special Provisions, California 2014 California Manual on Uniform Traffic Control Devices, and as shown on the Plans. The Contractor shall furnish all mounting hardware. Signs shall be constructed of 0.080" thick aluminum alloy.

### SECTION 12-2 TEMPORARY TRAFFIC SIGNS

All temporary traffic signs shall have Diamond Grade 3-M reflective sheeting (or approved equal by the City Engineer). The reflective sheeting shall conform to the Federal Specifications L-S300A.

The Contractor shall remove all temporary traffic signs, hardware, and posts when the work is complete.

### **SECTION 14** CONTROL OF WORK

### SECTION 14-1 GENERAL

A. Damages to Existing Facilities – Plant materials, portions of existing structures or facilities, including irrigation systems, which are damaged or altered in any way during the performance of work in this project, shall be immediately repaired or replaced in kind by the Contractor at their

expense and in a manner approved by the Engineer.

- B. Emergency Call Contractor shall respond to emergency calls for matters covered by this contract immediately without additional cost to the City. Contractor shall furnish the department with names and phone numbers of personnel available for emergency call-out purposes.
- C. Lock and Keys The Contractor shall be responsible for the series of 3 keys assigned to it and shall assign these keys to its personnel for use in maintaining the facilities. The Contractor shall properly use and keep safe all keys or locks issued by the City to the Contractor. The Contractor shall report all lost or stolen keys or locks to the City within 24 hours of discovery. The Contractor shall reimburse the City for the total cost of replacement keys and/or locks that have been lost.

### SECTION 14-2 PAYMENT OF LANDSCAPE MAINTENANCE

- A. Each month, the Contractor shall submit one invoice for payment as described in Section "Progress Payments", of these Special Provisions for payment for all work performed during the previous month. Payment shall be made on receipt of said invoice at the contract unit price per month for landscape maintenance of subject areas. Department pre-approval must be granted prior to work which ultimately shall be billed as separate payment items, except in the case of emergency repairs. If the invoice submitted by Contractor exceeds the contract unit price per month for landscape maintenance, Contractor shall also submit invoices verifying the purchase of materials, labor, and a clear description of the location of the installation(s), type of work done, and the date of the work.
- B. The price paid per month for landscape maintenance at each area shall include full compensation for labor, tools, equipment, and materials for landscape maintenance of each area, including weed control, scheduled spraying for insect and disease control, debris and litter removal, removal of dead, damaged, or diseased plant materials, staking and guying, irrigation of plant materials, fertilizer, pruning, edging, trimming, mowing, maintenance and repair of the irrigation system. The price paid shall not include compensation for repair of irrigation systems when the system malfunctions as a result of Contractor negligence.

At the request of the Engineer, the Contractor shall perform such work or repairs and replacements associated with the maintenance of the area that is not covered under the basic services under the terms of this contract. Extra services shall be performed according to a quotation submitted by the Contractor, approved by the Engineer, or shall be done on a time and

material basis. Compensation for extra work shall be made in accordance with the specified amount approved in this contract. No mark-up for handling fees or other fees beyond the basic labor and materials cost is allowable. The Contractor shall obtain written approval from the Engineer before proceeding with the work. The quotation shall show a complete breakdown of all labor and material costs.

C. Monthly Payments - The Contractor shall submit one invoice for payment in proper form to the City for all work performed during the previous month within five (5) calendar days following the last day of the previous month. The invoice shall list the area maintained and the date of the service with a total for all areas maintained during that month. Compensation will not be made for services not provided, as per Section 9 Work Description. If the invoice submitted by the Contractor exceeds the contract unit price per month for maintenance services, the Contractor shall also submit proof of approval to proceed from Engineer along with invoices of the location and scope of the services

provided. The invoice shall indicate the areas in which work was performed, the dates upon which work was done, and the type of service provided. Work resulting in separate and additional billing requires prior departmental approval before incurring costs

D. Invoices for payments shall be submitted to:

City of Salinas, Attn: Maintenance Manager Public Works Department 426 Work Street Salinas, CA 93901

Invoice shall be received within five (5) calendar days following the last day of the previous month.

E. After completion of the term of this contract and of all work called for under the contract and the value thereof, the City shall pay the entire sum so found to be due after deducting there from all previous payments and all amounts to be retained under the provisions of the contract. All prior partial estimates and payments shall be subject to correction in the final estimate and payment.

The final payment shall be in no way construed as an acceptance of any defective work. The Contractor agrees that the tender of the final payment by the City and acceptance thereof by the Contractor shall release the City, the Governing Body, the Engineer, and all other officers and employees of the City from any and all claims for liability or further payment on account of work done under the contract or alterations, additions, or reductions thereof.

### SECTION 14-3 SCHEDULE OF WORK

- A. Schedule of Work The Contractor's schedule for carrying out the work as specified shall be submitted to the Engineer for review and approval prior to the award of the contract by the City. The schedule shall include the time, days, and areas to be maintained.
- B. The Progress and Standard of Quality of Work The progress and standard of quality of work to be accomplished under this contract shall be of high quality. In the event of unsatisfactory maintenance as determined by the Engineer, Engineer shall require Contractor to correct the unsatisfactory work at no additional cost to the City for expenditures incurred in making the correction.

### 14-3.01 WORK SCHEDULE

- 1. The Contractor shall deliver to the City a complete landscape maintenance weekly work schedule along with the size of work crew and equipment summary sheet, prior to start of the maintenance contract.
- 2. The City retains the right to have certain work sites maintained on certain days.
- 3. Contractor is expected to have the same maintenance work crew assigned to its work sites at all times on a continuous basis.
- 4. Contractor at no time shall leave a work site to complete another sections project, without having completed the work assignment for that day.

5. No blowing in residential areas before 8:00 am.

### **SECTION 14-4 INSPECTIONS**

- A. Inspections Monthly inspections of the project site shall be scheduled by the City's authorized representative. This site inspection shall require that both the Contractor and City representative review the progress and satisfaction of the work product and to plan any work necessary to meet the landscape maintenance. Deficiencies noted during inspections shall be fixed as soon as possible, but in no case will the same deficiency be tolerated on the next monthly inspection.
- B. Should the Contractor fail to correct maintenance deficiencies within the first month of observation by the designated City staff project inspector, a payment reduction of an amount up to 25% of the total monthly maintenance fee may be withheld. In the event the Contractor fails to correct said deficiencies within the next month's billing period, the City may then retain an additional amount, up to 35% of that month's regular maintenance fee. Failure to correct deficiencies may result in termination of this contract.
- C. Deficiency Notice The Contractor is required to correct deficiencies within the time specified by the City of Salinas. If the deficiency is not corrected within the time specified by the City, City labor will be called out to complete the work. Such work shall be done on a force account basis with an additional call out charge of \$75.00 per hour for each call-out. Call-out of City forces during off hours, resulting from improper programming of sprinkler controllers, will be charged to the Contractor at time and a half. It also should be noted that there is a minimum two-hour charge for labor on any call-out.

### SECTION 15 MEASUREMENT AND PAYMENT

Payment for all labor, materials, tools, equipment and other appurtenances required for the proper, substantial and complete-in-place project construction for LANDSCAPE SERVICES FOR THE NORTH/EAST MAINTENANCE DISTRICT, as shown on the Plan and/or outlined in these Special Provisions.

Except for authorized changes in the work, payment for said complete-in-place finished work or improvement shall be made only on the basis of the Contract item of work listed in the Proposal. The various Contract item prices paid for the work required, for LANDSCAPE SERVICES FOR THE NORTH/EAST MAINTENANCE DISTRICT, complete-in-place, including full compensation for furnishing all labor, materials, tools, equipment and incidentals, for doing all the work involved in removing and disposal of various items of materials, provided for in these Specifications and Contract, or required for the proper completion of the work as a whole, for which no separate payment has been provided shall be a supplementary obligation for the Contractor and payment therefore shall be considered included in the price paid for the Contract item of work listed in the Proposal.

Reference Section 9-1.06 (page 9-11) of the Standard Specifications. Delete the last paragraph on page

9-11 and continuing first paragraph on page 9-12 and substitute the following:

The Contractor shall submit Subcontractor and/or suppliers waiver of liens as required under Civil Code Article 8122-8138. The waiver shall be "conditional" before payment and "unconditional" after payment on forms set forth in the statute.

The Contractor shall submit the progress payment pay application to the Engineer for review and approval. The Engineer shall review it within seven (7) calendar days of receipt. The Engineer shall either deny and return

the progress payment pay application to the Contractor for correction, or recommend approval and forward it to the Agency for processing. The required attachments to the monthly progress payment pay application shall include:

- A. Certified Payroll Reports: All current payroll reports and statement of compliance for the Contractors and all subcontractors (to be completed through the date of pay application).
  - Daily Reports: All current Daily Reports for the Contractor and all subcontractors and owner operators. Daily reports shall contain the name, classification and detailed task listing of all personnel and equipment, including all subcontractors and owner operators (to be completed through the date of pay application).
- B. Quantity Calculations: Certified quantity calculations to justify all pay quantities and amount requested.
- C. Monthly Schedule: The contractor shall submit an updated, revised construction schedule to the Engineer with each pay application.
- D. Unconditional Waiver of Lien Releases: The contractor shall submit Subcontractor and/or supplier's waiver of liens as required under Civil Code Article 8122-8138. The waiver shall be "conditional" before payment and "unconditional" after payment on forms set forth in the statute.

Failure to provide any of the documents as listed above will result in the Engineer returning the monthly pay application to the Contractor with no action.

Only "Stormwater" is allowed in our storm drain system. This pamphlet tells you how to prevent waterway pollution from "Stormwater" or "urban runoff."

Rain, industrial and household water mixed with urban pollutants creates Stormwater pollution. The pollutants include: oil and other automotive fluids, paint and construction debris, yard and pet wastes, pesticides and litter.

Urban runoff pollution flows through the storm drain to the Salinas River and the Reclamation Ditch that takes water and debris straight from Salinas streets to the Monterey Bay Marine Sanctuary. Each day, polluted urban runoff enters our rivers untreated, leaving toxic chemicals and trash to be carried downstream.

Urban runoff pollution contaminates our rivers, and ditches, harms aquatic life and increases the risk of flooding by clogging gutters and catch basins.

Utilizing Best Management Practices (BMPs) will ensure cleaner receiving waters and a cleaner City.

### REMEMBER: ONLY RAIN DOWN THE DRAIN!!!!!

### **General Construction Problems**

Construction sites are common sources of urban runoff pollution. Materials and wastes blown or washed into a street, gutter or storm drain flow directly to the ocean.

Sediment is the most common pollutant washed from work sites, creating multiple problems once it enters the ocean. Sediment clogs the gills of fish, blocks light transmission and increases ocean water temperature, all of which both fish and people depend on.

Sediment also carries with it other work site pollutants such as pesticides, cleaning solvents, cement wash, asphalt and car fluids like motor oil, grease and fuel. Thus, poorly maintained vehicles and heavy equipment leaking fuel and oil on the construction site also contribute to ocean pollution.

As a Contractor, site supervisor, owner or operator of a site, you may be held responsible for the environmental damage caused by your Subcontractors or employees.

### Solutions

Best Management Practices that include the proper handling, storage and disposal of materials can prevent pollutants from entering the storm drain system.

### **General Business Practices**

- V Keep pollutants off exposed surfaces. Place trash cans and recycling receptacles around the site.
- ✓ Cover and maintain dumpsters. Check frequently for leaks. Place dumpsters under a roof or cover with tarps or plastic sheeting. Never clean a dumpster by hosing it down on-site!
- Keep materials out of the rain. Cover exposed piles of soil or construction materials with plastic sheeting or temporary roofs.
- ✓ Designate one area for auto parking, vehicle refueling and routine equipment maintenance. The designated area should be well away from gutters or drains. Make all major repairs off-site.
- V Make sure portable toilets are in good working order. Check frequently for leaks.
- V Use as little water as possible for dust control.

### Cleaning Up

- 1. Clean up leaks, drips, and other spills immediately. This will prevent contaminated soil or residue on paved surfaces.
- 2. Never hose down "dirty" pavement or surfaces where materials have spilled. Use dry cleanup methods whenever possible.

### **Advanced Planning to Prevent Pollution**

An erosion control program, worked out before construction begins, prevents or minimizes most erosion and sedimentation problems.

- ☐ Train your employees and Subcontractors. Make these pamphlets available to everyone working on site. Inform Subcontractors about their own responsibilities.
- □ Schedule excavation and grading activities for dry weather periods.
- □ **Control surface runoff to reduce erosion,** especially during excavation. Use drainage ditches to divert water flow.
- □ **Prevent erosion by planting** fast growing annual and perennial grasses. These will shield and bind the soil.
- □ **Do not remove trees or shrubs unnecessarily.** They help decrease erosion.






































## East District Maintenance - Open Area Constitution to Walk Path
